JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Lajamang Mannow on 28/07/2025 filed an RTI application under Form-'A' before the PIO-Cum-EE, Department of (PWD.) Hayuliang Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 24/09/2025. The Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 14/11/2025 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 865/A/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission the 1st hearing held on 26/03/2026.

Details of Information as required:-

1. Certified Copy of Category of Work Charged (W/C) Staff serving under your Division.
2. Certified Copy of Appointment Letter of all the W/C Staff serving under your Division
3. Certified Copy of Place of posting of all the W/C Staff serving under your Division.
4. Certified Copy of total number of W/C Staff with name attached under CE(EZ) PWD NAMSAI, CE(SID&P) PWD Itanagar, SE, PWD, Tezu Circle, under PWD, Namsai Division etc from your Division.
5. Certified Copy of Recruitment Rules(RR) of Work Charged(W/C) Staff from Government of Arunachal Pradesh.
6. Certified Copy of Guidelines of Regulatory Scheme and Draft Recruitment Rules of W/C Staff from Competent Authority.
7. Certified Copy of approval from Competent Authority or SE, Advertise details, Interview or Viva details, Videography of Interview of W/C Staff.
8. Certified Copy of DPC, Trade Test of all the W/C Staff serving under your Division.
9. Certified Copy of Board members formed of all the W/C Staff recruited under your Division.
10. Certified Copy of Present Strength of W/C Staff under your Division.
11. Certified Copy of Total Strength of W/C Staff under your Division

In this hearing of the appeal on 26th day of March, 2026. The Appellant Shri Chow Lajamang Mannow, present during the hearing the PIO-cum EE (PWD) Hayuliang Division, present during the through online mode.

Heard the Appellant.

The Appellant stated before the Commission that some of the information have been provided to him which he has received through register post from the PIO. Except the information listed under Sl. No. e ,f, h ,i ,n & m are not given till today.

Heard the PIO.

The PIO stated that all the information available with his office have been provided to the Appellant and those information that are not available with his office have also been clearly written down on a letter addressed and sent to the Appellant which he has already received.

After hearing both the parties the Commission hereby observes and decide;

- i) Basing on the statements submitted by the Appellant and seeing the reply from the PIO in copies of the information furnished to the Appellant it is evident that the information available with the PIO have been furnished to the Appellant and the PIO has taken into consideration all the information that are not with his office by giving it in writing to the Appellant that the information are not available with his office.
- ii) In the submission of the Appellant to have received the information from the PIO, and those information not available with the PIO, in a letter written to him stating clearly that those information are not available with the office of the PIO, the APIC hereby after going through the set of information available with the Appellant is in consideration of the statements of the PIO that the information have been provided to the Appellant.

Under the above observations the APIC hereby dispose of this appeal by the consideration that the information have been provided to the Appellant by the PIO and therefore, this appeal is disposed of and closed once for all.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.


