JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Miss Bengia Mama, on 11/11/2024 filed an RTI application under Form-'A' before the PIO-Cum- DDSE, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 20/12/2024, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 10/02/2025, and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No-140/2025(Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for hearing on 27/5/2025, 13/11/2025 & 19/03/2026.

Details of information sought by the Appellants

1. Furnish a copy of appointment order and transfer posting order of Teaching Staff against Government Primary School Ramsing, Taliha, Upper Subansiri District Arunachal Pradesh in the year 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022 & 2023.
2. If issued any teacher from Government Primary School Ramsing, Taliha, Upper Subansiri District Arunachal Pradesh on temporary arrangement in the year 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022 & 2023 a copy of order may also furnish.
3. Period for which information asked for: In regarding as per information sought.

In the 3rd hearing held on 19th March '2026, related to the APIC No-140/2025. The Appellant Miss Bengia Mama is present. The PIO-cum-DDSE, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh present during the hearing through online mode.

Heard the Appellant

The Appellant stated that the PIO has provided her the information except the appointment order of temporary teachers.

Heard the PIO

The PIO stated that regarding the temporary teacher appointment there are no appointment order from the department of education as the school was managed and run by the community and the community only appointed the volunteering teachers temporary.

After hearing both the parties, the Commission hereby observes, that far-flung areas where development are yet to reach, the volunteering of certain individuals as teacher, to educate our children and engage as temporary teacher are praiseworthy and such teachers are appointed by the community on their own, and so there are no appointment order from department of education.

Under the above facts and observations the Commission hereby pass below orders;

On receipt of the documents available with the PIO by the Appellant completely, the Commission doesn't need to further hear this appeal and therefore, dispose of this appeal.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
