JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Dawa Tsering on **09/11/2025** filed an RTI application in Form- 'A' before the PIO of the Department of Industries, Bomdila, West Kameng District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **18/02/2025**, and the Appellant not receiving the required information from the FAA, as his appeal was disposed of by the FAA-cum-Deputy Commissioner, West Kameng District, ex-parte, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24/10/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **800/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **24.03.2026**, wherein the Appellant is absent without intimating to the Commission the reason for his inability to attend the hearing before the Commission.

The PIO of the office of industries, Bomdila, West Kameng District, is represented by his APIO Shri Phurpa Tsering, Extension Officer (EO), Bomdila, West Kameng District, Govt. of Arunachal Pradesh during the hearing before the Commission.

Heard the APIO;

The APIO stated that the Appellant had filed his Form-A on dated 08.11.2024 to which the office of the department of industries, Bomdila, West Kameg District had provided the information(s).

After that again the Appellant Shri Dawa Tsering filed another Form-A on 09.11.2024, to which the office of the PIO compiled the information(s) and written a letter to the Appellant to collect the information(s) by paying Rs. 836/- (rupees eight hundred thirty six only) as the cost of 408 (four hundred eight) pages information(s) on 13.03.2025, but instead of collecting the information(s) the Appellant had filed the First Appeal before the First Appellate Authority (FAA)-cum-Deputy Commissioner (DC), West Kameng District, Govt. of Arunachal Pradesh.

The First Appellate Authority (FAA)-cum-DC, West Kameng District, fixed the first hearing on 10.03.2025, wherein, the Appellant Shri Dawa Tsering failed to attend the hearing, in the failure of the Appellant to attend the hearing the FAA again fixed the another date for the second hearing on 12.06.2025, again the Appellant absented the hearing for the 2nd consecutive time, for which reason the FAA-cum-DC, West Kameng District, Govt. of Arunachal Pradesh, disposed of this appeal ex-parte.

During the hearing today the APIO exhibited the copies of the notice for the hearing ordered by the FAA-cum-DC, West Kameng District, and also the copy of the disposal of the first appeal.

Observations;

After hearing the APIO and seriously viewing the absence of the Appellant despite served with the notice of hearing for his appeal through WT Message on 22.12.2025, the Commission hereby considers his absent as intentional and not being serious on his appeal.

On seeing the exhibits as exhibited by the APIO the Commission comes to the conclusion to uphold the judgment of the FAA-cum-DC, West Kameng District, on 12.07.2025.

By upholding the judgment of the FAA-cum-DC, West Kameng District, the Commission hereby dismiss this appeal ex-parte

The details of information(s) sought by the Appellant from the PIO;

1. Furnish name list of all the funds sanctioned by state and central government in various schemes under department of Industries in west Kameng dist Bomdila, A.P with amount upto dated.
2. Furnish all details of allotted under skills development program by central and state flagship with name of beneficiaries, infrastructure created under all schemes of DIC, BOMDILA, Details of funds,geo tag number,photo and video in colourful. I will bring a memory storage with me with year upto dated.
3. Furnish list of all land allotment issued so far by department of industries to beneficiaries along with geo tag coordinate number, photo in color, accurate address, year and date of land allotment and measurement of land in "netre details, revenue amount details from allottee with guidelines directed by govt.
4. Furnish the details of accounts being operated by the DIC, Bomdila in copy of transaction and balance upto dated in year wise list.
5. Furnish guidelines for land allotments as per directed by govt. in year wise.
6. Furnish the details list of all types of funds allotted by Dy. Director of Industries Bomdila including DE, OC Minor works govt. quarter and office building maintenance, infrastructure development, photo copy of before and after work done, all note sheets.
7. Furnish the list of contingencies, casual staff appointed under DIC West Kameng showing their duty details copy of absentee statement, master roll etc, salary drawing under which head details, their process of salary transferred through DBT mode copies details.
8. Furnish name of all the beneficiaries along with accurate amount details transferred to their accounts as per guidelines of govt. with proper address and contact number details.
9. Furnish all requested documents in accurate amount, year wise details, names of schemes, physical and financial status/progress reports of all in accurate upto dated.
10. Furnish names of all board members for selection of beneficiaries till date along with the copy of resolution passed by board members for schemes, financial assistance, program organized and skills development achievements details.
11. Furnish all funds accurate year and date with. arrival and implementation of funds details.
12. Furnish all advertisement details published for the knowledge awareness of public in offlin and in online mode as per directed by govt guidelines to concerned department in year wise proper upto dated.
13. Furnish guidelines copy of all schemes, financialassistance, all programs organized for public knowledge and skills developments in year wise upto dated
14. Furnish all documents in certified true copy only.

15. If any documents I requested are personal or other issues to supply, please kindly reply must be in written within certain periods only.
16. If any documents I requested are personal or other issues to supply, please kindly reply must be in written within certain periods only.

Periods for which information is asked for: 2020 to till date of application is submitted.

Order;

In view of the above facts and circumstances the Commission dismiss this Appeal. And, accordingly, this Appeal stands dismissed and closed once for all.
