Information sought :

The appellant file an RTI Application dated 26/10/2024 seeking Details regarding C/o Rehabilitation and Upgradation of Miren-Mikong-Jonal Road (1-15.568 km) under the North East Road Sector Development Scheme (NERSDS) in Arunachal Pradesh during the financial year 2020-2021.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 30/11/2024. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tamchi Gungte absent.

Respondent : PIO-cum-EE (PWD), Pasighat Division is represented by Er. Tapang Tatak, AE.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte 26/10/2024 filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer(PWD), Pasighat Division, East Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **30.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16/01/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 84/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) times i.e on 09/07/2025 and 08/10/2025. In this hearing of the appeal on **8th day of October, 2025**, the PIO-sum-EE(PWD), Pasighat Division is represented by Er. Tapang Tatak but the appellant Shri Tamchi Gungte found absent, however, he has submitted and application addressed to the State Information Commissioner requesting to dispose of the appeal case No. APIC-83/1015 and stating that he has received all the information as sought and is satisfied.

Request accepted and the appeal case No. APIC-84/2025 is disposed of and closed.
