Information sought :

The appellant file a RTI Application dated 27/03/2025 seeking Details regarding :- Deen Dayal Upadhya Swavalamban Yojana.

As per the case record, PIO has not provided information in time.

Being dissatisfied, the appellant filed First Appeal dated 27/03/2025. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants ShriNyake Bojir & Dedak Gadi on **27.03.2025** filed an RTI application under Form-'A' before the PIO-cum-DPO(District Planning Officer), Basar, Leparada District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **05.05.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **25.06.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 521/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three time i.e on 17/11/2025, 21/01/2026 and 06/04/2026. In this hearing of the appeal on 6th day of April, 2026, the PIO present in person and PIO stated that all the available information have been provided to the appellant on direction of Commission, the PIO-cum-DPO, Basar had written letter to the Bank's Concerns to provide the information. The regional Manager State Bank of India Dibrugarh has given his reply Stating that the disclosure of information sought by the appellant are exempted under 8(1) (e) and 8(1)(j) of the RTI Act. As per the order before the FAA dated 10.09.2025, It is seen that the appellant had agreed to seek the information directly from the Bank himself since the information sought by him are available with the Bank. But the appellant is found absent without any intimation to the Commission.

As per the case record before the FAA, the appellant had agreed to seek information directly from the concern Bank for the information. Since all the information sought are with the Banks, the present PIO has nothing to furnish, the appellant is advise to file the application seeking the information before the concern Banks.

In consideration of the statement by the PIO, the Commission deems that the information sought is not available with the PIO and accordingly the appeal case No. APIC-521/A/2025 is disposed of and closed.


