ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tania June for non-furnishing of below mentioned information by the PIO, o/o the Deputy Commissioner (DC), Palin , Kra-Daadi District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 27.05.2025:

Brief records emerging from the appeal:

Records in the appeal reveal that the appellant had requested for the aforementioned information from the PIO but failed to obtain the same which prompted him to file his 1st appeal under section 19(1) of the RTI Act before the Deputy Commissioner, Palin, Kra-Daadi District, the First Appellate Authority (FAA) vide his memo of appeal dt. 23.07.2025. However, the appellant having failed yet again to obtain the information, preferred his 2nd appeal before this Commission under Section 19(3) of the RTI Act 2005 vide his memo of appeal dt. 18.09.2025.

Hearing and decision:

This appeal was accordingly, listed heard in this Commission today on 23.01.2026 wherein both the appellant, Shri Tania June and the PIO, Shri Rido Tarak, the ADC, o/o the D.C, Kra-Daadi District, the requested information/documents are present in person.
