JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Kamnga Ronya on **10/09/2024** filed an RTI application in Form- 'A' before the PIO-cum-DMO/DRCHO, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **13/12/2024**, and even then, the Appellant not receiving the required information from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **06/02/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **112/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **12.07.2025, 23.09.2025 & 20.01.2026.**

Details of information sought from the PIO;

1. Answer Script/Answer Sheet of all selected candidates and wait listed candidates of both written and skill test.
2. A copy of advertisement No. APMHM/2022/23 Dated NLG. The 18th July' 2023.

In the 4th hearing held on 20.01.2026 related to APIC No-112/2025, the Appellant Shri Kamnga Ronya found absent consecutively for the 2nd time as he was absent in the 3rd hearing held on 23rd September' 2025 also without intimating the Commission the reason for his inability to attend the hearing.

The PIO who was present through online mode in the 2nd hearing held on 31.07.2025 had stated before the court of the Commission that he has provided all the information(s) to the Appellant as sought in his Form-A except the information sought in Serial No. (a) of the Form-A of the Appellant.

The Appellant in the 2nd hearing on 31.07.2025 had stated before the Commission that all the information(s) have been provided by the PIO except the Serial No. (a) of his Form-A.

The Commission had ordered the PIO on 31.07.2025 in the 2nd hearing to provide the information(s) sought in Serial No. (a) of the Form-A of the Appellant to which the PIO had agreed to provide the same information in the court of the Commission.

To ascertain the receipt of the said information from the Appellant the Commission fixed the 3rd hearing on 23.09.2025, wherein the Appellant Shri Kamnga Ronya found absent and the PIO also found absent without intimation to the Commission the reasons for their absence.

In the absence of both the parties in the 3rd hearing held on 23rd September' 2025 the Commission had strictly ordered the Appellant to be present in the next date of hearing which is the 4th hearing to be held today on 20th January' 2026 with a clear order that the consecutive absence of the Appellant in the hearing will allow the Commission to hear and determine this appeal ex-parte.

Under the above stated facts and circumstances the Commission hereby orders;

- i) Due to the absence of the Appellant consecutively after being notified the date of hearing makes the Commission believe that the Appellant is not serious on his appeal and simply with some ulterior motives have filed this appeal to harass the PIO as well as to waste the precious time of the Commission.
- ii) In the consecutive absence of the Appellant in the 2 (two) hearings the Commission hereby decides to dismiss this appeal forthwith.

Order;

In view of the above facts and circumstance the Commission dismiss this Appeal ex-parte. And, accordingly, this Appeal stands dismissed and closed once for all.
