Information sought:

The appellant filed an RTI application dated 08.08.2025 seeking following information regarding

C/o "Details of Projects work and supply work from the financial year 2017-18 to till date.

There particulars of information required are as follows:-

C/o "Details of Projects works and supply works":

1. Furnish the certified total list of projects and supply work executed in, along with the details of project amount under Director of Trihms from each financial year i.e. from 2017-18 to till date.

2. Furnish the certified copy of Ongoing project works and supply works along with details of contractor executing the work under TRIHMs, from each financial year i.e. from 2017-18 to till date.

3. Furnish the certified copy of completed projects works and supply works along with the details of contractor under TRIHMs from each financial year i.e. from 2017-18 to till date.

The following were present.

Appellant : Present. He states that neither the FAA has heard the appeal nor the PIO has furnished information.

Respondent PIO : Present. He has brought the information document today in the commission court during hearing.

On interjection the appellant received the information document from the PIO and agreed for closure of this appeal case.
