**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Leleen Regon on 22/1/2025 filed an RTI application under Form-'A' before the PIO-Cum- Directorate of Economics & Statistics, Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 24/2/2025, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 25/03/2025 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No-283/A/2025(Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1<sup>st</sup> hearing on 11/09/2025 & 12//03/2026.

**Details of information required**

Details of sanctioned posts and vacancy status along with name of incumbents, date of promotion, date of retirement and reasons for vacancy in respect;-

- i) Jt. Director,
- ii) Deputy Director as per the format enclosed,

Period for which information asked for :- As on 31 December, 2024

In the 2<sup>nd</sup> hearing held on 12<sup>th</sup> March 2026, related to the APIC No.283/A/2026 (Appeal). The Appellant Shri Leleen Regon, present during the hearing but the PIO -cum Directorate of Economics & Statistics, found absent without intimating the reason for his inability to attend the hearing which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties, also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI, Act 2005, which is a statutory duty binding upon the PIO.

**Heard the Appellant**

The Appellant stated before the Commission that he didn't get notice for the 1<sup>st</sup> hearing from the Commission and so he could not attend the 1<sup>st</sup> hearing but as he got the notice for the 2<sup>nd</sup> hearing, he is present today in the court of Commission. The PIO has provided the information but it was unsatisfactory and so I filed the First Appeal at the First Appellate Authority (FAA) by which the FAA has ordered the PIO to provide copy of information, after which the PIO provided the information but I was not satisfied with the information provided by the PIO, I filed the 2<sup>nd</sup> appeal before the Arunachal Pradesh Information Commission (APIC).

After hearing the Appellant, the Commission hereby observes;

That the Appellant has got all the information as the PIO has provided the information as applied by the Appellant and on proper scrutiny by the Commission it is found that the information have been completely provided as per the form 'A of the Appellant.

After the above observations the Commission hereby decides;

- i) The complete information have been provided to the Appellant by the concerned PIO and the Commission hereby does not see any reason to further the hearing of this appeal as the complete information have been provided to the Appellant. Therefore, the Commission herby dispose of this appeal and close it.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
