**An Appeal Case U/S 19(3) of RTI Act, 2005**

**Case No. APIC- 833/2025.**

**APPELLANT** : Shri Kimin Ingo, Paya Vill., Aalo.

**RESPONDENT** : The PIO, o/o the (BDO), CD Block, Aalo West, West Siang Distt.

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Kimin Ingo for non-furnishing of below mentioned information by the PIO, o/o the (BDO), CD Block Aalo West, West Siang District Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.03.2025:

**A) Particular of Information:** c/o PHC Building with compound wall at Nikte/  
Kodum Circle in West Siang District(A.P).

**B) Details of Information required**

1. Furnish Sanction order/copy.
2. Furnish Details Project Report (DPR).
3. Furnish Work order.
4. Furnish TS copy.
5. Furnish Geo Tagging details in coloring photos. The Longitude and Latitude must be clear and visible.
6. Furnish detail copies of Material Procurement of Challans.
7. Furnish Photograph of project before, during and after the completion of the project in coloring photo.
8. Furnish Payment Cheque leaf/ PFMS/DBT transaction receipt copy till date.
9. Furnish Letter of Credit (LOC)
10. Furnish Notice Inviting Tender (NIT) details with NEWS paper cutting.
11. Furnish the Name of bidder with detail supporting documents of the same.
12. Furnish Name of all the tender participants with detail documents.
13. Furnish the details of Bank Guarantee from which National Bank has been submitted by Contractor.
14. Furnish a copy of Approved drawing & assurance letter from the nearest IIT/ NIT.
15. Furnish details on the grounds for rejection of the technical bids of all bidders who were disqualified in the evaluation process. This should include specific deficiencies or no-compliances with the tender requirements.
16. Furnish copies of the contractor licenses of the selected bidder, including the date of registration and any relevant updates or renewals.
17. Furnish Completion Certificate.
18. Furnish Utilization Certificate.
19. Furnish details of monthly monitoring report from Directorate Office, SJETA with coloring photos during spot visit by the monitoring team from Director Office, SJETA, Itanagar.
20. Furnish quality assurance certificate from the nearest IIT/NIT.
21. Prayer for an immediate inclusion in Government Receipt Accounting System (GRAS) or Online Mode of Payment System for payment of Challan as your department is not yet included in online mode of payment.

22. Furnish all the documents in proper paging with CTC in each page and please to furnish within 30 days from the date of receipt as per RTI act otherwise the appellant is not liable to pay any fees as per sub-section (6) of the Section (7), RTI Act, 2005.

C) Period for which information asked for: 2023-2024

**Brief facts emerging from the appeal and decision:**

The records in the appeal reveal that the appellant, Shri Kimin Ingo had requested the PIO for the aforementioned information in response to which the PIO-cum-BDO, Aalo West CD Block, Aalo, West Siang District, vide his letter dt. 26.03.2026 (as extracted below) informed the appellant that **the PIO has not executed or implemented the scheme.**

*"It is to inform you that the office of the undersigned has not yet executed or implemented the scheme, "C/o PHC Building with compound wall at Nikte/Kodum circle in West Siang District, A.P".*

*This is for your information and further necessary action please.*

The appellant dissatisfied with the reply of the PIO approached to the Director (SJETA), the First Appellate Authority (FAA) under section 19(1) of the RTI Act. 2005 vide Memo of appeal dtd. 24.04.2025. The FAA heard the appeal on 4<sup>th</sup> July, 2025 and passed the following order:

**"RTI JUDGEMENT ORDER**

*The hearing before the First Appellate Authority (FAA) was held on 04 July 2025 at 4:00 PM in the office chamber of the Director, S/ETA, Government of Arunachal Pradesh, Itanagar,*

*The above PIOs are hereby directed to furnish the information sought by the applicant during the next hearing. The next hearing is scheduled on 18 August 2025 at 4:00 PM in the office chamber of the Director, SJETA, Government of Arunachal Pradesh, Niti Vihar, Itanagar.*

*The following PIOs have already submitted the requisite information as sought by the applicant*

PIO, PWD Division, Capital Complex.*

*All remaining PIOs mentioned above are hereby directed to appear without fail for the next hearing on 18th August 2025 at 4:00 PM and furnish the complete information as per the applicant's request*

*As per Section 19(6) of the RTI Act, 2005, the each concerned PIOs are required to bring two copies of the information to be furnished to the applicant during the hearing.*

The appellant, apparently, dissatisfied with the response of the FAA and the PIO, filed his 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of RTI Act vide his appeal Memo dt. 06.11.2025.

This appeal is, accordingly, listed today on 18.03.2026 but neither the appellant nor the PIO or any of his representatives appeared which has been viewed very seriously by this Commission. Such absence of the parties, more particularly, the absence of the appellant, has made this Commission presume that he is satisfied with the replies from the o/o the PIO vide letter dt. 26.03.2026 as extracted above and resultantly, this appeal requires no further adjudication in this Commission. Hence, this appeal is closed for once and for all.
