ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Riya Taram, Huto Colony Jollang, C/o Riang Store Jollang, near Catholic Church, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (RWD), Tawang Division, Tawang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 12/03/2025 regarding **relevant information of work and sanctioned amount under the funding head of SIDF 2021 to 2023.**
- 2). The 2nd hearing was held on 17th March' 2026 (Tuesday) at 1100 hrs. Er. Phurpa Tsering, PIO- Cum- EE (RWD), Tawang Division, Tawang District, Arunachal Pradesh appeared before the Commission through online Video Conferencing. The Appellant Shri Riya Taram was absent.
- 3). During the 1st hearing held on 10th February'2026 the Appellant Shri Riya Taram had submitted a request letter addressed to the Commission vide letter No. Nil dated 10/02/2026 before the court hearing stating that he could not attend the court hearing as he had been suffering from fever.
- 4). Based on the application of the Appellant, the Commission accepted the request for re-scheduling of the next Court hearing; however, the Appellant was directed to produce the medical report before the Commission on the date of hearing as a proof. If he failed to produce the medical report it would be assumed that the Appellant was absent without valid reasons and stern action would be initiated against him.
- 5). The PIO submitted that information were kept ready and that he had intimated the Appellant to collect the same from the office but the Appellant had failed to turn up till date.

6). The Commission, in view of the repeated absence of the Appellant from the court hearing without any valid and prior intimation, decides to dispose of the case.

7). Therefore, the case is hereby disposed of.
