JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Dawa Tsering on **20/02/2025** filed an RTI application in Form- 'A' before the PIO of the Department of Industries, Bomdila, West Kameng District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **23/05/2025**, and the Appellant not receiving the required information from the FAA, as his appeal was disposed of by the FAA-cum-Deputy Commissioner, West Kameng District, ex-parte, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24/10/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **799/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **24.03.2026**, wherein the Appellant is absent without intimating to the Commission the reason for his inability to attend the hearing before the Commission.

The PIO of the office of industries, Bomdila, West Kameng District, is represented by his APIO Shri Phurpa Tsering, Extension Officer (EO), Bomdila, West Kameng District, Govt. of Arunachal Pradesh during the hearing before the Commission.

Heard the APIO;

The APIO stated that the Appellant had filed his Form-A on dated 08.11.2024 to which the office of the department of industries, Bomdila, West Kameg District had provided the information(s).

After that again the Appellant Shri Dawa Tsering filed another Form-A on 09.11.2024, to which the office of the PIO compiled the information(s) and written a letter to the Appellant to collect the information(s) by paying Rs. 836/- (rupees eight hundred thirty six only) as the cost of 408 (four hundred eight) pages information(s) on 13.03.2025, but instead of collecting the information(s) the Appellant had filed the First Appeal before the First Appellate Authority (FAA)-cum-Deputy Commissioner (DC), West Kameng District, Govt. of Arunachal Pradesh.

The First Appellate Authority (FAA)-cum-DC, West Kameng District, fixed the first hearing on 10.03.2025, wherein, the Appellant Shri Dawa Tsering failed to attend the hearing, in the failure of the Appellant to attend the hearing the FAA again fixed the another date for the second hearing on 12.06.2025, again the Appellant absented the hearing for the 2nd consecutive time, for which reason the FAA-cum-DC, West Kameng District, Govt. of Arunachal Pradesh, disposed of this appeal ex-parte.

During the hearing today the APIO exhibited the copies of the notice for the hearing ordered by the FAA-cum-DC, West Kameng District, and also the copy of the disposal of the first appeal.

Observations;

After hearing the APIO and seriously viewing the absence of the Appellant despite served with the notice of hearing for his appeal through WT Message on 22.12.2025, the Commission hereby considers his absent as intentional and not being serious on his appeal.

On seeing the exhibits as exhibited by the APIO the Commission comes to the conclusion to uphold the judgment of the FAA-cum-DC, West Kameng District, on 12.07.2025.

By upholding the judgment of the FAA-cum-DC, West Kameng District, the Commission hereby dismiss this appeal ex-parte

The details of information(s) sought by the Appellant from the PIO;

- i) Furnish original photo copies of all work orders including ongoing works sanctioned by State & central Govt under Director of Industries through Planning & investment year/session wise.
- ii) Furnish original photo copies of beneficiaries for unnati, PMEGP, PMFME schemes list along with their submitted documents of Address proof, Contact number, DBT, DPR, Photo copy, Photo copies of bank statement/bank passbook for the last 6 months, Estimate and Qualification of all capital expenditure and Machineries and Equipment to be purchased, Photo of existing unit, Details of site where unit is established whether owned//rented/leased? and Proof thereof, Audited balance sheet with annexure of max 3 years with ITR, Board resolution for availing loan etc if any to transact the amount, Copy of license as per industry (FSSAI, Pollution clearance, ESI etc) if available, GSTIN Registration certificate, Memorandum and Articles of association, certificate of incorporation/Registration, list of Directors/Share holders/Beneficial owners and brief bio data attested by authorised signatory and OVD of each Director duly attested by authorised signatory details file records DIC Bomdila.
- iii) Furnish original photo copies of OE,OC and all infrastructure development details, in Geo tag coordinate accurate numbers, MIS reports, completion certificate, money receipt to firms, DPR, PFMS reports awarded letter, LOC released and LOC demands, details in colourful clear photo of before and after work, with the name of work, physical and financial target reports details, utilization certificate, first to final bill copies. A memory storage will be handed while receiving information.
- iv) Furnish all copies of advertisement details to local newspaper. If not reply in written format only.
- v) Furnish certified photo copy details of firms with valid registration certificate and all the other relevant documents of contractor who executed the all work orders for OE,OC and infrastructure development under DIC Bomdila.
- vi) Furnish details of all documents in front page of letter for smooth understanding
- vii) Furnish names of all subsidies, schemes, work orders with full amount in year/session wise authentic details and furnish authentic circular and guidelines photo copies in year/session wise approved through DIC Bomdila by Central & State Government.
- viii) Furnish all the documents of original photo copies as per file records under DIC Bomdila. Don't compromise on this information. If any documents are short or not in your records kindly reply in written format only.
- ix) Furnish all the Documents in CTC only. Don't compromise on this information.
- x) Furnish names of all the officers incharge for billings and surveying specific work orders with their respected post and designation, with approval of amount transaction letter attested on.

- xi) Furnish original photo copies of money receipt by firms for all work orders. Kindly a clear copy must issued.
- xii) Furnish photo copies of board procedure resolution passed for selection of beneficiaries, along with signature attested of all the board members in year/session wise for PMEGP, UNNATI, PMFME only.
- xiii) Furnish original photo copies file records exist in DIC Bomdila, for Land measurement in metres, Geo tag coordinates number details, Revenue amount Details collected by land allot tees so far from 2018 to till date and full transaction details transfer to direct Government of Industries account.
- xiv) Furnish full details of expenditures for surveying and monitoring Industries Land by concerned Department if it is irrelevant then kindly reply me in written format with CTC
- xv) Furnish full transaction details of SBI Account no 31601262056 operated by DIC Bomdila from period of 2020 to till date in photo copy of original.
- xvi) Furnish authorized letter to inspect account no 31601262056 SBI bank manager, for transaction details records and legal procedure. If cant issue such order then reply must be in written format only acceptable. If you have misconception of such information to furnish then kindly go through RTI act section 74(2) for public document.
- xvii) If any documents i requested are irrelevant, misconception or inappropriate then kindly reply me in written format or contact me. Contact number is mentioned below in signature of applicant.

Period for which information is asked for 2018 to till date.

Order;

In view of the above facts and circumstances the Commission dismiss this Appeal. And, accordingly, this Appeal stands dismissed and closed once for all.
