The appellant file a RTI Application dated 14/05/2025 seeking Details regarding :-
PMKSY(HKKP) 2022-2023.

As per the case record, PIO has not provided information in time.

Being dissatisfied, the appellant filed First Appeal dated 21/06/2025. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Pisa Tapam on **14.05.2025** filed an RTI application under Form-'A' before the PIO-cum-EE(WRD), Ziro Division, Lower Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21.06.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **19.08.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 637/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three time i.e on 17/11/2025, 21/01/2026 and 06/04/2026. In this hearing of the appeal on 6th day of April, 2026, the PIO and appellant is found absent without any intimation to the Commission.

As per the case record, the Appellant is absent consecutively 3 times dated on 17/11/2025, 21/01/2026 and 06/04/2026 without any intimation. Therefore the Commission presumes that the appellant has no more interest to persue this appeal case. The Commission deems fit to close this appeal case. Accordingly the appeal case No. APIC-637/A/2025 is disposed of and closed.


