JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tamchi Gungte on **11/06/2025** filed an RTI application under Form-'A' before the PIO-Cum-CE, (RWD) PMGSY, Itanagar Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **16/07/2025**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **25/08/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-666/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1st hearing on **16/10/2025**.

Details of information sought by the Appellants.

1. Furnish the certified total list and nos. of projects sanctioned under PMGSY from the Ministry of Rural Development, Govt. of India to Arunachal Pradesh in District wise and Phase wise (i.e. Phase I, II, III, IV) from the initial to till date.
2. Furnish the certified copy of all sanction Order as per serial no. 1 mentioned above.
3. . Furnish the certified objectives of each phase (I, II, III & IV) of the PMGSY scheme.
4. Furnish the certified copy of minimum requirement of population (as per census) for applying the PMGSY Scheme in the Arunachal Pradesh for unconnected habitations in rural areas.
5. Furnish the certified copy of Population census (2001 & 2011) for each project submitted to the ministry of Rural Development for all the unconnected habitation in rural areas for approval under PMGSY scheme for phase I,II,III & IV.
6. Furnish the certified copy of total list of projects ongoing and completed projects under PMGSY scheme in phase wise (I, II, III & IV) in entire Arunachal Pradesh as per Executing agencies.
7. . Furnish the certified copy of PMGSY Guidelines.

In the 1st hearing on **16th day of October '2025**, the Appellant found absent, due to his health issues as informed to the Commission over telephone. The PIO –cum, Chief Engineer (RWD) is present during the hearing through online mode.

The Appellant Shri Tamchi Gungte though absent has informed through a phone call to the Commission on **16/10/2025** stating that he has received all the information(s) as sought in his Form 'A' application and requested the Commission for disposal/closure of his appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
