ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/ PS Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding MRL20-Namtok EAC HQ to Nakang during the financial year 2024-25.
- 2). The 2nd hearing was held on 22nd July 2025. Shri Nyamar Rike, the PIO-cum-EE(RWD), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh had appeared before the Commission through video conferencing. The Appellant Shri Tamchi Gungte was present in person before the Commission.
- 3). In the hearing due to contradiction of views of both the parties i.e. the PIO and the Appellant, the Commission had directed the Appellant to forward a fresh list of non-furnished documents to the PIO with a copy endorsed to the Commission within 15 days from the date of issue of the order dated 22nd July'2025. The Appellant on 30/07/2025 had submitted a copy of fresh list of non-furnished documents.
- 4). The PIO was directed to report action taken after receipt of the letter dated 30/07/2025 from the Appellant but the PIO has not reported of any action taken till date.
- 5).Also, in case the information had been furnished by the PIO, the Appellant was directed to intimate his satisfaction or dissatisfaction to the Commission within twenty days from the date of issue of this order dated 4th December'2025 and had cautioned that in case of failure to do so the case would be disposed of. The appellant has failed to intimate his satisfaction or dissatisfaction to the Commission.

6). The Commission, in view of the order dated 4th December'2025 in the larger public interest decides, to dispose of the case.

7). Therefore, the case is hereby disposed of.
