ORDER

- 1). This is a complaint under Section 18(1) of RTI Act, 2005 filed by Shri Basanta Khattiya Deori, Mahadevpur-I, P.O. & P.S. Mahadevpur, District Namsai, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(WRD), Govt. of A.P., Department of Water Resource, Namsai Division, District Namsai Arunachal Pradesh, as sought by the complainant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/08/2024 Community Hall Project for Mahadevpur-I & II.
- 2). The 2nd hearing was held on 2nd December 2025 as scheduled. Shri C.J. Mannou, PIO-cum-EE(WRD), Govt. of A.P., Department of Water Resource, Namsai Division, District Namsai Arunachal Pradesh was represented by Adv. Bajangso Kri. The Complainant, Shri Basanta Khattiya Deori was present.
- 3). The representative of the PIO had brought two sets of information stating that the information pertained to Mahadevpur-I & II as sought by the Complainant. The sets of information were received by the Complainant before the Commission's court.
- 4). The Complainant was directed to go through the information and intimate his satisfaction or dissatisfaction to the Commission within fifteen days from the date of issue of the order dated 2nd December'2025. Despite reasonable time provided the Complainant has failed to intimate to the Commission. So, the Commission, in view of the order, decides to dispose of the case.
- 5). Therefore, the case is hereby disposed of.
