2. Furnish a copy of sanction order and sanction amount regarding the conduct of Mega Health Camp cum Awareness Camp in respect to the office of the APB & OCWWB, West Siang District Aalo in the year 2020, 2021, 2022, 2023, 2024 and 2025.
3. Furnish a copy of the Guidelines, Rules and Regulation and any kind of directive from the APB & OCWWB as well as from government of Arunachal Pradesh for the distribution of welfare kids to the beneficiaries.
4. Furnish a copy of the "Name and Designation of the appointing authority" of any staffs right from RO to Peon in the APB & OCWWB Arunachal Pradesh.

5. Furnish all the documents with proper paging along with proper CTC within 30 days from the date of receipt.
