JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Sengman Ronrang on **26/07/2024** filed an RTI application under Form-'A' before the PIO-Cum- Project Director RD, Changlang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12/09/2024**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12/12/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-18/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for hearing on **8/5/2025, 19/8/2025, 25/11/2025, & 31/03/2026..**

Details of information sought by the Appellants.

- 1) Period of information required: 2022 to 2024.
- 2) Details of information required: (A) sanctions order copy (B) Technical sanctioned order copy (C) NIT Copy and news Paper clips of NIT (D) utilisation certificate against the sanctions (E) NOC (F) Details of Cash book (G) details of firm and name of the proprietor used in all transactions and payments made (H) details list of local entrepreneurs participants firms name and company name during tender process (I) details of account transactions records receipt vouchers against the firm till date. (J) Location of the work execution side with photograph and videos, (k) bedding and quotation details.
- 3) Provided details information of funds & schemes heads under ZPM GPC & GPM (Panchayat).
- 4) From SL No 4 to 10 under which lam seeking details of information must be same as shown in the reference no. Provided by the concerned authorities and department 2022 to 2024 with original authority seal and signature of concerned department should be same.
- 5) The information can be furnished within 30 Days as per prescribed under section 6 (1) of RT) Act 2005.
- 6) Kindly furnish the other details of all the information should be duly signed by the PIO on every page.

In the 4th hearing held on 31st March 2026, related to the **APIC No-18/2025(Appeal)**. The Appellant Shri Sengman Ronrang, found absent consecutively from the first hearing despite being notified of the hearing on **08/05/2025, 19/08/2025 and 25/11/2025**, and the PIO-cum Project Director DRDA, Changlang District Govt of A.P, is absent. In the absence of both

parties the Commission while going through the documents decide on this appeal as given below;

- i) The Appellant was absent in the 1st hearing held on 08/05/2025 without reason of his absence intimated to this Commission.
- ii) In the 2nd hearing held on 19/8/2025 the Appellant was absent again and in the 3rd hearing the Appellant was absent again without informing to the Commission the reason for his absence. In the continued absence of the Appellant in the hearings despite being notified for the hearing in advance, the Appellant's absences have been considered as intended and non serious of his appeal.
- iii) Considering the 4th consecutive absence of the Appellant, in the hearing for this appeal, the Commission hereby view the continued absence of the Appellant as intentional as well as non serious of his appeal and therefore, the Commission find this appeal fit to be disposed of, ex-parte.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
