JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Miss Bengia Mama, on 10/10/2024 filed an RTI application under Form-'A' before the PIO-Cum- -EE (PWD) Basar Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 22/11/2024, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 10/02/2025, and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No-139/2025(Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for the hearing on 27/5/2025,13/11/2025 & 19/03/2026.

Details of information sought by the Appellant

1. Furnish a copy of Continuation Order of Muster Roll appointed by Superintending Engineer (S.E) Basar Cirde, PWD, A.P and Executive Engineer (EE) Basar Division, PWD, A.P from April 2018 to March 2024.
2. Furnish a copy of Salary and Wages Allotment Order of each Month from April 2018 to March 2024.
3. Furnish a copy of Monthly Expenditure of Salary and Wages from April 2018 to March 2024.
4. Furnish a copy of Salary and Wages posting order of each month from April 2018 to March 2024.
5. Furnish a copy of LOC and Allotment Order of T.A/D.A. & TTA from April 2018 to March 2024.
6. Furnish a copy of LOC/Allotment Order of OC/OC POL and OE from April 2018 to March, 2024.
7. Furnish a copy of Expenditure Details of OC/OC POL and OE from April 2018 to March 2024:
 - (a) Work Order/Supply Order.
 - (b) Counterfoil or cheque.
8. Furnish all the documents within 30 days as per RTI Act, 2005. If concerned PIO would fails to furnish all the seeking documents within stipulated time then as per Under Section 7 (6) of RTI Act, 2005, the appellant shall not be liable to pay any fees for the same.
9. Furnish all the documents with proper CTC.

In the 3rd hearing held on 19th March '2026, related to the APIC No-139/2025. The Appellant Miss Bengia Mama is present. The PIO-cum EE (PWD) Basar Division, Govt. of Arunachal Pradesh, absent during the hearing.

Heard the Appellant

The Appellant stated that the PIO has furnished the complete information for the year 2018-2019, for which the court of the Arunachal Pradesh Information Commission (APIC) had ordered the PIO.

In the submission of the Appellant that all the information have been given to the Appellant by the PIO as per the order passed in the last hearing. The Commission hereby doesn't find any reason to further this appeal and therefore, in receipt of the complete information by the Appellant the Commission hereby dispose of this appeal and close it once for all.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
