ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Miss Bengia Mama for non-furnishing of below mentioned information by thePIO, o/o the (BDO), CD Block Damin, Kurung Kumey District as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 20.01.2025.

A. Particulars of information: C/o Wire Rope Suspension Bridge to Pabin ricer between Tangba to Keba village, Kurung Kumey District.

B. Details of information:

1. Furnish Sanction order/copy.
2. Furnish Details Project Report (DPR)
3. Furnish Work order
4. Furnish TS copy
5. Furnish Geo Tagging details in colouring photos 2023-2024.
6. Furnish detail copies of Material Procurement of Challans
7. Furnish Photograph of project before during and after the completion of the project in coloring photo.
8. Furnish Payment Cheque leaf/ PFMS/DBT transaction receipt copy
9. Furnish Letter of Credit (LOC)
10. Furnish Notice Inviting Tender (NIT) details with NEWS paper cutting.
11. Furnish the Name of bidder with detail supporting documents of the same.
12. Furnish Name of all the tender participants with detail documents.
13. Name of the Officers involved in the said project.
14. Furnish a copy of Approved drawing & assurance letter from the NIT.
15. Furnish details on the grounds for rejection of the technical bids of all bidders who were disqualified in the evaluation process. This should include specific deficiencies or no-compliances with the tender requirements.
16. Furnish copies of the contractor licenses of the selected bidders, including the date of registration and any relevant updates or renewals.
17. Furnish Completion Certificate.
18. Furnish Utilization Certificate.
19. Furnish details of monthly monitoring report from Directorate Office, SJETA.
20. Furnish all the documents in proper paging with CTC in each page and please to furnish within 30 days from the date of recipe as per RTI act otherwise the appellant is not liable to pay any fees as per sub-section (6) of the Section (7), RTI Act, 2005.

C. Period for which information asked for: 2023-2024.

This appeal was heard on 13.02.2025 and 27.03.2026.

On 13.02.26, both the appellant and the PIO, Shri Tadar Takar, BDO, o/o the BDO, CD Block Damin (with the requested documents) were present in person.

The documents brought in by the PIO were handed over to the appellant with direction to go through the same and report the shortcomings, if any, to this Commission within 1(one) week from the date of receipt of this order for further consideration of the appeal.

In compliance with the order dt. 13.02.2026, the appellant, Ms. Bengia Mama, vide her letter dt.16.02.2026 has complained that the PIO has failed to furnish the replies/information to queries at Sl.No.14(copy of Approved drawing & assurance letter from the NIT) and Sl. No.19(details of monthly monitoring report from Directorate Office, SJETA) and accordingly, pleaded for hearing the appeal again.

This Commission, in terms of the provisions of section -7(8)(i) of the RTI Act r/w section-18(3)(c) and rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005, directed the PIO to furnish the left out information or/and an affidavit against the information/documents not held by the o/o the PIO to the appellant in right earnest and report the compliance therewith on 27.03.2026, the next date of hearing.

Today on 27.03.2026, the appellant, Ms. Bengia Mama is present through VC while the PIO is present in person with the affidavit dt.25.03.2026 sworn in by him and declaring therein the reasons/explanations for denying the replies/documents against the 2(two) queries namely, Sl.No.14(copy of Approved drawing & assurance letter from the NIT) and Sl. No.19(details of monthly monitoring report from Directorate Office, SJETA).

This Commission perused the affidavit and notices that the PIO has duly complied with the requirement of law and this Commission's order dt.13.02.2026 entailing this Commission to conclude that this appeal now no longer requires adjudication in this Commission. As such it stands disposed of and closed.

The appellant shall collect the copy of affidavit in original from this Commission on next working day i.e on 31.03.2026.
