ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Jollang, Near Himalayan University, Itanagar, PO /PS Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/05/2025 regarding Land allotment and its related details of Power House, Niti Vihar, Itanagar.
- 2). The 1st hearing was held on 25th November' 2025. Ms Byabang Naemeh, PIO-cum-DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh and the Appellant Ms Bengia Mama were present.
- 3). The PIO had informed the Commission that the information sought by the Appellant could not be traced in any records in her office. So, in that regard a letter had been forwarded to the Power Department.
- 4).The Commission had directed the PIO to once again write to the Power Department under intimation to the Commission and also furnish a copy to the Appellant. The authority of the Power Department was also served with a copy of the order, directing them to furnish information to the DLRSO Capital Complex or directly to the Appellant within fifteen days from the date of issue of the order dated 25th November'2025.
- 5). The Commission had asked the Appellant to approach the PIO or the concern authority of the Power Department and collect information. After receipt of information the Appellant was directed to intimate his satisfaction or dissatisfaction by 24th December 2025. The Appellant was cautioned that in case he failed to intimate to the Commission within ten days from the expiry of above date given, the case would be disposed of. The Appellant has failed to intimate her satisfaction or dissatisfaction to the Commission even after being given reasonable time. So, the Commission decides to dispose of the case.

7). Therefore, the case is hereby disposed of.
