JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the AppellantS, Shri Odi Menjo and others on **26/03/2025** filed an RTI application in form 'A' before the PIO-cum-EE, PHED & WS, Roing Division, Lower Dibang Valley District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellants being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **27/05/2025**. Appellants again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on **25/07/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **597/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **16/09/2025 & 13.01.2026**. Details of Information sought from the PIO;

Details of information required: Authenticated Xerox copies of following :

- i) DPR
- ii) Sanction Order (Total amount sanctioned for above scheme).
- iii) Notice Inviting Tender (NIT).
- iv) News paper cuttings where NIT was published.
- v) List of all the Tender contenders.
- vi) Work Order.
- vii) Geo-tags of Intake point, Main tank.
- viii) List of beneficiaries along with geo tags of platform/tap connection.
- ix) Photographs of site (Intake tank & Main Tank) before execution, during half construction and after completion of the work.
- x) Detail credentials of Firm which Executed the project:
 - a) Registration Certificate
 - b) Documents submitted for NIT process.

Period for which information asked for: -2021-2024.

In the second hearing held on 13th January' 2026: one of the Appellant present.

The PIO is absent.

Heard the Appellants:

The Appellant present among the Appellants stated that the PIO has provided the information sought completely, but no covering letter addressed to the Appellants, and therefore, the Appellant requested the Commission to order the PIO to furnish a covering letter with seal and sign and certify that the copies of the information furnished are true copy, and so the PIO is requested to put in the Certified True Copy (CTC) mark and sign all the copies of the information provided to the Appellants.

After hearing the Appellant the Commission hereby order;

1. The PIO to provide CTC on all the pages of the information(s) copies or else provide a single covering letter addressed to the Appellants stating that the copies of the information provided by the PIO are certified true copies.
2. The Commission on the request of the Appellant disposed of this appeal as the information(s) have been provided completely by the PIO to the Appellants, save, the certification as certified true copies.

Under the above circumstances and facts the Commission hereby disposed of this Appeal with a clear order to the PIO to provide the Appellants a certificate certifying that all the information copies are certified true copy.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed once for all.
