ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram for non-furnishing of below mentioned information by the PIO, o/o the EE Yatdam Electrical Division, Changlang as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 08.08.2025:

A) Particular of Information: To furnish all the relevant information against the work carried out under the Funding Head of Accounts 4801-Maintanance of ASSETS for: 1. year 2022-23=Rs. 47.72/-
2. year 2023-24=Rs. 90.00/-
3. year 2024-25=Rs. 100.00/-

B) Details of Information required

1. Give the Certify Copy of Notice Inviting Tender(NIT)/work Order/Supply order /Technical Sanction(TS) Copy/First & Final Bill with details of contractor/firm bill payment Such as Scan copy of Cheque leaf/demand draft/banker cheque/Pay In Slip for NEFT/RTGS slip in respect of above mentioned amount.
2. Furnish the Geo-tag of Work i.e Before Starting of Work, Ongoing of Work and after Completion of Work of all the above Specified work with amount.
3. Give the Contractors/firms bill Payment Money Received List with Proof documents such as Pan card/Aadhar Card/ST/PRC/domicile certificate/Voter ID Card/Mobile Number/3 nos pass photo of Person who received the bill payment against above mentioned work with amount as per your NIT Guidelines.
4. Give the Name of Contractors & firms with Letter Pads/Xerox copy of Trading License with Contact number/Aadhar Card/Pan Card/ST/PRC/Voter ID Card/3 nos pass Photo of firm Proprietor/Owner as per your NIT Guide lines in respect of above mentioned work with amount.
5. Give the Money receipt/cash memo of Supply materials/Quantity/Rate/amount of items/Quotation.
6. Give the Name Bidders who Participated in the Technical & financial bids along with Comparative Statement/Hand Receipt with Payee Name/integrity pad signed between Bidders and Executive Engineer in Respect of above Specified work with amount.
7. Give the details of MB Records/Cashbook Statement of all the above Specified work with amount.
8. Give the Certified Coloring Photocopy of all the Work Sites-by Concern Pio.
9. Give the Copy of GST Return filed for work/Supply work wise or year wise with showing the deduction of % against each firm and work/Supply work wise during the year like GST.
10. Give the Name of Officers & Officials who executed the above mentioned Works with amount.
11. Give details of Enlistment of contractor as per work department Rules Act 2008.
12. Give details of proprietor of firm/Registration of certificate.

13. Give the Money deposited Challan of Govt. account against GST/Royalty by EE department/firm in work wise.
14. Give the List of amount Transaction from EE division account to all the AE Sub-division account in year wise/work wise.
15. Furnish the Authorization letter of EE/SE/CE Eastern Zone to all the AE Sub-division for Opened and Operated Separate Bank account at AE Sub-division level in the name of Assistant Engineer power Sub-division with their contact number/Aadhar card/Pan card/Job ID Card/ST/PRC/3 Nos pass photo of all the AE, Who Operated the Account. Also Please give Account Number/Cheque leaf of all the AE Account.

Brief facts emerging from the appeal and decision thereof:

Records in the appeal reveal that the appellants had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the First Appellate Authority (FAA), the Chief Engineer (Electrical Eastern Zone), Namsai under section 19(1) of the RTI Act vide their Memo of Appeal dt. 30.09.2025. But having failed yet again to obtain the information, he preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dt. 03.11.2025.

This appeal is, accordingly, listed today on 18.03.2026 wherein the appellant Shri Riya Taram is absent without any intimation. The PIO, Shri Nyanu Doji, EE, o/o the Yatdam Electrical Division, Changlang District, A.P. attended the hearing through video conference.

The PIO submitted that the sought for information were ready to be handed over to the appellants and that vide letter dt. 19th September, 2025 (as extracted hereunder), the appellants was advised to deposit a sum of Rs.894.00 and collect the same but the appellants did not turn up to collect the documents.

"In continuation with this office letter no. YaED/E-12/RTI/2025-26/475 dt. 19/09/25, it is to inform you that amount to be deposit as the cost of information on the work "Maintenance of assets" or the period from 2022-25 under RTI Act, 2005 is Rs. 894/- (i.e 2x447 page) (Rupees eight hundred ninety four) only instead of Rs. 976/- through e-GRAS portal in favour of Arunachal Pradesh Electrical Circle-III under H/A-0070 OAS (0070-60-118-00-00) and collect the information on or before 23rd September, 2025 during office hour by submitting the e-challan please.

This correction has been made after proper verification of the page numbering. As page numbering were not corrected due to clerical mistake.

This is for your information and necessary action please.
