JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tamchi Gungte on 3/6/2025 filed an RTI application under Form-'A' before the PIO-Cum- EE (UD & Housing) Dept Ziro Divisin, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority **on 7/7/2025**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission **on 4/8/2025**, and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-608/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for hearing **on 13/11/2025 & 19/03/2026.**

Details of information sought by the Appellants

1. Furnish the certified Sanction Order Copy with the list of Anganwadi centre to be executed.
2. Furnish the certified copy of Proof (such as Voter ID and PRC) that the tender winning firm Domicile status within the Territorial jurisdiction of that Constituency Assembly as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015.
3. Furnish the certified copy of Technical Sanction done by the concerned Authority for the projects as per financial rules.
4. Furnish the certified copy of Utilization Certificate.
5. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
6. Furnish the certified copy of Criteria of eligibility for CPWD/APPWD as well as non-CPWD/non-APPWD contractors in this project.
7. Furnish the certified Progress Report of the projects in Physical and Financial section till date.
8. Furnish the certified copy of Completion certificate of the project.

9. Furnish the certified copy of Newspaper in which NIT was published (At least 3 newspaper name (one National & 2 Local)) along with date of publication of Newspaper, as per Government approved Order.
10. Furnish the certified Design and Scope of Work in the projects.
11. Furnish the certified copy of Work Specification of the projects.
12. Furnish the certified copy of documents submitted by tender participant for Technical Bid.
13. Furnish the certified copy of Tender participant who have qualified the Technical Bid in the Tender Process of this projects as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015.
14. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.
15. Furnish the Details (Name, Designation (then & now), currently posting location) of Officers who were responsible for monitoring the work before and till date.
16. Furnish the certified copy of Contractor Registration, of the tender participant and tender winning Firm.Composite Category as per the nature of work), of tender participant and winning Firm.
17. Furnish the certified copy of Contractor Enlistment Order (Civil/composite category as per the nature of work), of tender participant and winning firm.
18. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
19. Furnish the certified Integrity Pact submitted by the tender participant.
20. Furnish the certified Affidavit copy (The Affidavit should mention the names of the incomplete ongoing commitments) Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have

In the 2nd hearing held on 19th March 2026, related to the APIC No-608/2025(Appeal). The Appellant Shri Tamchi Gungte found absent during the hearing with a letter of absence and PIO-cum EE (UD & Housing) Dept. Ziro Division, is present during the hearing in person.

Heard the PIO.

The PIO stated that in the last hearing which was held on 6/11/2025 also I have stated before the court that this office has not executed any work as written in the form'A of the Appellant. Therefore, he does not have any idea how to provide and what to provide the information for work that he is totally not in the know. He has written to the Appellant stating the same reason that his office has not executed any such work and therefore, cannot provide any information about such work that he is not in the know and also he doesn't know which executing agency has executed, the said works as cited by the Appellant in his form'A' application.

After hearing the PIO the Commission hereby observes;

i) In the last hearing which was held on 6/11/2025 the PIO was present in the court and stated that his office has not executed such work as applied for information by the Appellant. That the same was given in written to the Appellant.

By the above stated observations the Commission hereby passed the below orders;

i) Taking into consideration the statements of the PIO that his office has not executed any work as applied for information by the Appellant, therefore there are no information to be furnished to the Appellant for which the PIO also has given in writing to the Appellant and considering the statements of the PIO, the Commission also feels no information can be furnished to individuals without availability of such information in the office of the PIO and therefore the Commission doesn't find any reason to further hear this appeal and dispose of this appeal and close it once for all.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
