**SUMMON**

**WHEREAS**, in connection with the **APIC-No. 793/2025**, your personal appearances required before the Commission on **11<sup>th</sup> June 2026 at 10:30 AM**. The 1<sup>st</sup> hearing held on **26<sup>th</sup> March' 2026**. The Appellant Shri Katung Tana is present during the hearing before the Commission.

The PIO-cum-EE, PWD, Pakke Kessang Division, Govt. of Arunachal Pradesh absent despite being notified of today's hearing through WT Message sent on 27.01.2026.

Heard the Appellant;

The Appellant stated that he filed the Form-A before the PIO on 26.06.2025.

The PIO on 23.07.2025 has written to him to submit an amount of Rs. 1123/- (rupees one thousand one hundred twenty three only) as the cost of 313 pages of information(s) for which I have paid the fees through e-pay challan on 26.07.2025.

Despite the payment of the fees for the information(s) the PIO has failed to provide the information(s), and therefore, I filed the First Appeal before the First Appellate Authority (FAA)-cum-Superintending Engineer, HQ, W/Zone, PWD, Govt. of Arunachal Pradesh, Itanagar.

After which the FAA on dated 16.09.2025 passed an order against the PIO to furnish me with all the information(s) as I had applied. But till today the PIO has failed to provide me the information, and therefore, I have filed the Second Appeal before the Arunachal Pradesh Information Commission (APIC).

After hearing the Appellant and going through the document exhibited by the Appellant the Commission seriously viewing the absence of the PIO despite being notified of today's hearing to him on 27.01.2026, the Commission hereby pass the below orders;

- i) Send Summons to the PIO to be present in the next date of hearing without fail, failing which necessary action against him will be instituted as per the provisions of RTI, Act, 2005.
- ii) The PIO to provide the complete information(s) as applied by the Appellant on or before the next date of hearing.
- iii) The Appellant to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.
- iv) Send the notice for the next date of hearing to the PIO.
- v) Notice for the next date of hearing need not be served to the Appellant as he is present during the hearing before the Commission.

**The Commission hereby orders;**

**The next date of hearing be fixed on 11<sup>th</sup> day of June' 2026 at 10:30 AM (Morning).**
