**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of 31(thirty one) point information on the implementation of the following 6(six) schemes by the PIO, o/o the E.E (PWD), Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 23.05.2025.C/o G+II Type-III teacher quarter at Govt. Hr. Sec. School, Koloriang, Kurung Kumey District.

1. C/o School building for Govt. Sec. School Sarli, Kurung Kumey District.,
2. 3) C/o Infrastructure development within VKV School, Koloriang, Kurung Kumey District.
3. C/o G+II RCC school building for academic block at Govt. Hr. Secondary School, Koloriang, Kurung Kumey District.
4. C/o Helipad at Malapu near Circuit House, Koloriang, Kurung Kumey District.
5. C/o Office building for CO Panisang and Polosang Circle, Kurung Kumey District.

This appeal was heard on 27.02.2026 wherein the appellant was absent but the PIO was represented by Shri Bini Tare, the PA-cum-RTI i/c o/o the EE (PWD) Sangram Division.

This Commission, after hearing the representative of the PIO and on perusing the letter dt.16.10.2025 submitted by him regarding the handing and taking over of the charges between the o/o the EE, Koloriang PWD Division and the o/o the EE, Koloriang PWD Division effected on 14.10.25 pursuant to bifurcation of the Koloriang Division from the Sangram Division, directed the PIOs of both the Sangram Division and the Koloriang Division to be present on 27.03.26 so as to enable this Commission to decide as to whose office shall furnish the requested information/documents to the appellant.

The PIO, o/o the E.E (PWD) Koloriang Division and the PIO o/o the E.E (PWD), Sangram Division were, therefore, directed to be present in person in the next hearing on 27.03.2026 with records / evidence of handing over and taking over of the charges of records/documents pertaining to schemes falling under the jurisdiction Koloriang Division.

Today on 27.03.2026, the appellant is present in person. The PIO, o/o the E.E (PWD), Sangram Division, Er. Shri Modak Riba is also present in person but the PIO, o/o the E.E (PWD) Koloriang Division is absent without any intimation which has been viewed seriously by this Commission.

Since the PIO, o/o the E.E (PWD) Koloriang Division is required to be heard but he is absent, this appeal is again listed on 22<sup>nd</sup> April, 2026. This Commission, at the same time reiterates its earlier direction to the PIOs to be present on that date with the requested documents. It is made clear that if the PIO, o/o the E.E (PWD) Koloriang Division does not appear or depute any representative in the hearing, this Commission shall be constrained to invoke the penal provisions of the RTI Act against him.
