  - h. Furnish certified true copy of mane of project manager/ supervisor.
  - i. Furnish certified copy of Land Identification and clearance of forest.
  - j. Total area of land allocated for the said project.
  - k. Certificate/ No objection certificate of project received for environmental clearance (EC) from the Ministry of Environment, Forest and Climate Change (MoEFCC).
  - l. Total no. of Elephants which were proposed to be rescued/ rehabilitated.
  - m. Furnish certified copy of progress/ compliance reports submitted by the project authorities to the Forest department.
  - n. Furnish details of the facilities planned for Elephant viz medical care, food, shelter, water etc.
  - o. Furnish certified copy of public consultation report and Gram Sabha Member of meeting that was held under executing agency.

- p. Furnish certified copy of payment made through public Financial management System (PFMS) to the tender winner firm.
  - q. Furnish certified copy of MB.
  - r. Furnish certified copy of completion report/ certificate.
  - s. Furnish certified copy of utilization certificate as per General financial Rule (GFR) 19-A and
  - t. Present status of the said work.
3. Period for which information asked for: 2023-2024.
