WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 794/2025**, your personal appearances required before the Commission on **08th September 2026 at 02:30 PM**. The 2nd hearing held on **11th June' 2026**. The Appellants represented by Shri Birandra Tallong present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), WRD, Itanagar Division, Chimpu, Papumpare District, Govt. of Arunachal Pradesh is absent despite being notified of today's hearing on 26.03.2026.

Heard the Appellant;

The Appellant stated that the PIO has provided him certain information and not the complete information as applied by him. - ii) Summons be issued to the PIO-cum-EE, WRD, Itanagar Division, Chimpu, Papumpare District, Govt. of Arunachal Pradesh to be present in the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.
- iii) Notice for the next hearing need not be sent to the Appellants as Shri Birandra Tallong is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 8th day of September' 2026 at 2:30 PM (Evening).
