SUMMONS/ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Mamu Sono for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (RWD), Seppa Division, East Kameng District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 06.11.2025.

A. Particular of information: regarding the c/o Road from New Seppa (9km) Point on Seppa Tallang road to Loffa-Stage- I & II.

B. Details of information require:

1. Furnish the copies of MOA/MOU/agreement made in between RWD Department and concern company/firm for the Implementation of above mentioned Project under the RWD, Department.
2. Furnish the copies of total sanction amount order letter along with additional sanction amount.
3. Furnish the copies of executed contractors/firms name.
4. Furnish the copies of acceptance letter awarded to the contractors/firms.
5. Furnish the copies of financial, technical & final bidding documents.
6. Furnish the copies of quantity of work executed till date.
7. Furnish the copies of U/C submitted by the department to the State government/central government.
8. Furnish the copies of monitoring report, money receipt and completed report.
9. Furnish the copies of name of the third party monitoring agency along with guidelines for third party monitoring or implementation of the above mentioned project/ scheme.
10. Furnish the copies of News paper cutting published in any local or national news paper agency as NIT with front page which were published by which news paper agency.
11. Furnish the copies of name and the place where the work executed/ implemented.
12. Furnish the copies of details of GST payment or bills paid or in details.
13. Furnish the copies of works experience, documents of the Firms/contactors.
14. Furnish the copies of completion certificate of the work.
15. Furnish the copies of P/A holder and name of firm/company in details.
16. Furnish the copies of colour videos, audios and photos clips were taken (before, during and after the work executed/completed.
17. Furnish the copies of GEO-TAGG (Before, during and after the work executed/completed.

18. Furnish the copies of work order and total numbers of tender participated list & total list of selected Firms for awarded the project.
 19. Furnish the copies of DPR In details.
 20. Furnish the copies of all letter pad/DO letters by Hon'ble Minister, MLAs for awarding of contract work.
 21. Furnish the copies of NIT & NIQ submission letters.
 22. Furnish the copies of cheque issued to contractor, firm, agency and company with cheque no. In details.
 23. Furnish the copies of money paid to firm/contractors and balance amount.
 24. Furnish the copies of MB & Copies of payment Bill/Payment of Bouchers.
 25. Furnish the copies of present status of the project.
 26. Furnish the copies of EMD and copy of Bank Guarantee (BG)
 27. Furnish the copies of Security money deposited by the firms/contractors.
 28. Furnish the copies of Trading Licenses In details and profile details.
 29. Furnish the copies of comparative charts/statement charts.
- F) Period for which information required: Since from execution of work to till date.

Brief facts emerging from the appeal:

Records in the appeal reveal that the appellants had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the Chief Engineer (RWD) (PMGSY), Itanagar, the First Appellate Authority (FAA), under section 19(1) of the RTI Act vide Memo of Appeal dt. 09.02.2026. But having failed yet again to obtain the information, he preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dtd. 26.03.2026.

This appeal was, accordingly, listed on 15.07.2026, but none of the parties appeared.

This Commission, however, noticed that the FAA did not consider the appeal as mandated under section 19(1) of the RTI Act. Hence, this Commission, vide order dt. 15.07.2026, remanded this appeal to the said FAA for adjudication and passing an appropriate order in speaking form within 1(one) month from the date of receipt of the said order.

This Commission also concluded that the appellant, if aggrieved by the decision of the FAA, may prefer his 2nd appeal before this Commission under section 19(3) of the RTI Act within 90(ninety) days from the date of the FAA's order.

Records in the appeal reveal that the FAA had listed the appeal for hearing on 04.08.226 but the appellant did not appear and as such the appeal was disposed of without any direction on merit as under:

“JUDGEMENT

Whereas, hearing was conducted on 04th August 2026 vide order No: RWD/PMGSY/RTI-167/2025-26 Dated 30th July, 2026. RTI case APIC No. 299/2026 & APIC No. 300/2026.

This Commission, is now in receipt of letter dt. 14.09.2026 from the appellant, Shri Mamu Sono complaining that the o/o the Chief Engineer (RWD) (PMGSY), Govt. of Arunachal Pradesh, Itanagar, the FAA did not take any action on the appeal despite the direction from this Commission and therefore, requested for admitting and hearing the appeal. The extract of the appellants' letter is as under:

"R/sir,

With due respect and humble submission, I have the honor to inform you that I have filed RTI Form-A, O/o the Executive Engineer-cum-PIO, RWD Seppa Division, E/Kameng District, (A.P) after 30 days over filed first appeal O/o the FAA-cum-CE, RWD (PMGSY) Cell Itanagar, Arunachal Pradesh but yet no any seeking information documents receipt again after 30 days over filed 2 appeal in the RTI commissioner Court, and on 15th July 2026 the first cause listed and first hearing was held, but I was unable to attend the hearing due to some unavoidable urgent work after the hearing you have noticed there is no FAA hearing record enclosed and appeal was remanded back to the Chief Engineer-cum-First Appellate Authority, RWD(PMGSY), Cell Itanagar accordingly because of non-enclosed judgement order copy of the FAA.

That, after remanded for conduct the hearing under FAA-cum-Chief Engineer, RWD (PMGSY) Cell, Itanagar (A.P) to adequate giving opportunity to both the appellant and the respondent PIO, accordingly the First Appellate Authority-cum-the Chief Engineer, RWD (PMGSY) Cell Itanagar, Arunachal Pradesh has conducted hearing at his court of office chamber on 4th August 2026 and the appeal was disposed off but after 30 day (one month) more days still not furnish any single piece of seeking information documents from the Executive Engineer-cum-PIO, RWD Seppa Division, E/Kameng District (A.P)

Therefore, I highly honor you kindly fixed/list my appeal for continue conducting hearing to obtain all required relevant seeking information documents from the EE-cum-PIO, RWD Seppa Division East Kameng District Arunachal Pradesh and direct/endorse the respondent (PIO) provide information documents to the applicant within short period of time or bring all seeking information documents in next date of hearing.
