ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Chungma Sangbia for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD) Longding Division, Longding District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 03.02.2026.

A. Particulars of information: regarding c/o Barrel Free Environment SIPDA Scheme

B. Details of information required:

1. Furnish the tender advertisement copy.
2. Furnish the name contractor and sub contractor with firm name.
3. Furnish the list of payment against out of 18-building by name.
4. Furnish the agreement copy between department with tender winner.
5. Furnish the progress report from beginning to till date.
6. Furnish the detail money transaction of cheque book Xerox copy.
7. Furnish the work completion report with drawing book.
8. Furnish the total payment bill and balance amount.
9. Furnish the sanction order copy.
10. Furnish the utilization certificate copy.
11. Furnish the NOC/Permission letter from HOD for Office Building and School Building
12. Furnish the total amount against the ongoing project and total release payment record copy and also total balance amount is yet to pay.
13. Furnish the monitory team report if any record copy.
14. Furnish the Geo-Tagg
15. Furnish the guidelines against the said project
16. Furnish the by name of all the Engineers (EE, JE, AE, Surveyor) to look after this project.
17. Whether, if any Training was conduct for Barial Free Environment, then issue those certificate with proper signature.
18. Furnish the Bill voucher copy.

C. Period for which information is required: regarding as per information sought.

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the Appellant, Shri Chungma Sangbia had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to file 1st appeal before the Chief Engineer (PWD) E/Zone, Namsai as the First Appellate Authority (FAA) u/section 19(1) of the RTI Act vide his appeal Memo dated 06.04.2026. But having failed to obtain the documents / information from the PIO he filed his 2nd appeal before this Commission u/s 19(3) of the RTI Act vide Memo of appeal dt. 19.05.2026

Hearing and decision:

Accordingly, this appeal is listed today on 16th Sept. 2026 wherein both the appellant, Shri Chungma Sangbia and the PIO, Er. Shri Takon Taju, E.E are present in person.

Heard the parties.

The appellant, reiterating his demand for the information/documents as sought for by him, pleaded for an appropriate direction to the PIO to furnish him the information.

The PIO, on the other hand, submitted that no scheme by the name of "c/o Barrel Free Environment SIPDA Scheme" under which the appellant had sought the information, was executed by his Division and therefore, the disclosure of information as requested by the appellant does not arise and that the appellant should file fresh application specifically and clearly mentioning the particulars of information. The appellant, however, clarified that the scheme was for providing 'barrier free facilities' to the physically challenged persons (PwD) and the name of the scheme ought to have been, "Barrier Free Environment" which has been inadvertently written as, "Barrel Free Environment" in his RTI application. On a pointed query, the PIO admitted having executed some schemes including buildings pertaining to such scheme by his Division and on advice by this Commission, assured to furnish documents/information relating to the scheme, as are available, to the appellant.

In the premises as above, the PIO is directed to furnish the requested documents/information to the appellant within 1(one) month from the date of receipt of this order and report the compliance thereof to this Commission on 23.10.2026, the next date of hearing.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined, including closure of the appeal, in your absence.

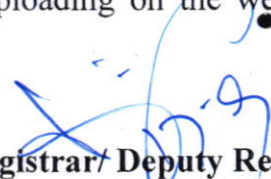
