WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 907/2025**, your personal appearance is required before the Commission on **19th November, 2026 at 10:30 AM**. The **3rd hearing held on 15th Sept' 2026**. 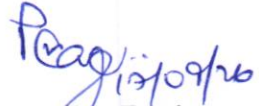
