SUMMONS

10. Furnish a copy of the details of transferred amount viz time, date, Month and Year from department account to the winner firm.

 13. Furnish Name of all the tender participants along with detail documents.

 18. Society the reason making MOU/MOA with Nyiko Gumin Multipurpose operative society Ltd. Only?
 19. Furnish a copy of UC.
 20. Furnish a copy of the name and details list of the land donor for the said scheme.
 21. Furnish all the documents in proper paging with CTC in each page and please.
