ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Rakhini Mipi for non-furnishing of below mentioned information by the PIO, o/o the DFO, Anini, Dibang Valley District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 10.11.2025.

A) Particulars of information: the information pertaining to CAMPA is required from Division Forest Office, Anini w.e.f 01 Jan 2015 to till date.

B) Details of Information:

1. Furnish a copy of approved Detailed project Reports.
2. Furnish a copy of approved sketch map of the area acquired.
3. Furnish a copy of approved technical sanction order.
4. Furnish a copy of approved Notice Inviting Tenders (Cutting of Newspaper).
5. Furnish a copy of approved tenderers documents.
6. Furnish a copy of approved comparative statement of tender.
7. Furnish a copy of security deposits.
8. Furnish a copy of each bills and vouchers by participating tender
9. Furnish a copy of all payments with cheque No & date (If payment made through PFMS then provide PDF copies of payment details.
10. Furnish a copy of approved technical inspection reports.
11. Furnish a copy of cancelled/amended/modifications made by agency.
12. Furnish a copy of completion reports (If completed).
13. Furnish a copy of map showing boundary details with Length x Breadth, Longitude and Latitude (Geo-coordinate) etc.
14. Furnish a copy of NOC from various individuals/Clans/Communities & Villagers.
15. Furnish a copy of Gram Sabha meeting details, attendance copy with minutes of meetings.

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the appellant, Shri Rakhini Mipi had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Conservator of Forest, Tezu, Lohit District, (A.P), the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 05.01.2026.

The appellant having failed yet again to obtain the information preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 08.02.2026.

This appeal was, accordingly, listed for hearing on 20.05.2026 wherein the PIO, the DFO, Shri T. Rime appeared through VC but the appellant was absent without any intimation.

This Commission, however, found that the First Appellate Authority (FAA), the CCF, Tezu did not consider the appeal as required under section 19(1) of the RTI Act, 2005. As such, vide order dt.20.05.26, the appeal was remanded to the First Appellate Authority, the CCF, Govt. of Arunachal Pradesh Tezu, for adjudication and passing an appropriate order within 4(four) weeks from the date of receipt of this order with liberty to the appellant to come back to this Commission under section 19(3) of the RTI Act if he is dissatisfied or aggrieved by the decision of the First Appellate Authority.

This Commission is now in receipt of letter dt.23.06.2026 (as reproduced hereunder) from the appellant informing that the First Appellate Authority (FAA), the CCF, Tezu did not consider the appeal despite this Commission's order dt. 20.05.26.

"Respected Sir,

I had filed an RTI application (dated-10th Nov, 2025) seeking information from the concerned Public Information Officer (PIO). Since the information was not provided, I approached the concerned authority through appeal.

A First Appeal Order (dated-11th June, 2026) was passed directing the concerned authority to provide the information. However, till date, the information has not been furnished to me despite the order.

Therefore, I kindly request your good office to direct the concerned PIO to comply with the order and provide the complete information at the earliest.

I also request your good office to kindly consider taking appropriate action under Section 20 of the RTI Act, 2005, if deemed fit, for non-compliance of the order and delay in providing information.
