3. Furnish a copy of the details and the nature of appointments (advertisement/promotion/direct appointments) to all the staffs right from contingency to Group A staff in your department since 2018 to till date.
4. Furnish a copy of the appointment orders of all the staffs right from contingency to Group A staff in your department since 2018 to till date.
5. Furnish a copy of the posting places of all the staffs (right from contingency to Group A staffs) who have been appointed by your department since 2018 to till date.
6. Furnish a copy of the details of the qualification of all the appointed staffs (right from contingency to Group A staffs) who have been appointed by your department since 2018 to till date.

7. Furnish all the documents with proper CTC in each page.

C. Period for which information is required: regarding as per information sought.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC in person on 9th October, 2026 (Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined, including closure of the appeal, in your absence.
