WHEREAS, in connection with the **APIC-No. 386/2025**, your personal appearances required before the Commission on **09th June 2026 at 02:30 PM**. The **2nd** hearing held on **24th March' 2026**. The Appellant Shri Bamang Pacho is present during the hearing before the Commission.

The PIO-cum-EE, PWD, Sangram Division, (Shri Modak Riba) Kurung Kumey District, Govt. of Arunachal Pradesh, found absent despite notice for hearing served unto him for two times through WT Message on 10.09.2025 and other sent on 20.11.2025 to be present for hearing of the 2nd appeal preferred against him by the Appellant Shri Bamang Pacho.

Heard the Appellant:

The Appellant stated before the Commission that he has not yet been provided the information from the office of the PIO.

In the absence of the PIO the hearing could not be undertaken, and therefore, the Commission hereby pass the below orders;

- i) To issue Bailable Warrant of Arrest to the PIO-cum-Executive Engineer, PWD, Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh, Shri Modak Riba to be arrested and brought before this court to hear him in the interest of justice.
- ii) To issue the Bailable Warrant of Arrest order to the Officer-In-Charge (OC), Sangram Police Station, for executing the bailable warrant of arrest and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on 09.07.2026, at 2:30 PM, without fail, before this court.
- iii) The copy of this bailable warrant of arrest be served to the Superintendent of Police (SP), Kurung Kumey District for compliance.
- iv) Notice for the next date of hearing need not be served to the Appellant, as he is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 9th day of June' 2026 at 2.30 PM (Evening).
