SUMMON.

WHEREAS, in connection with the **APIC-No. 430/2025**, your personal appearance is required before the Commission on **02nd June 2026 at 02:30 PM**. The 1st hearing held on **17th March' 2026**. The Appellant Shri Taba Rajan, is absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing. The APIO stated that all the documents as applied by the Appellant had been already furnished by the PIO, after that again the Appellant had filed the First Appeal, before the First Appellate Authority (FAA)-cum CCF Banderdewa. Wherein also the PIO provided yet another set of information to the Appellant. I don't know what reason Shri Taba Rajan, filed this second Appeal, whereas whatever information he has asked the PIO have been furnished twice over to the Appellant.

After hearing the APIO the Commission could not ascertain the veracity of the submission of the APIO whether what he is stating is correct and therefore, the Commission decided to fix a next date of hearing for the Appellant for considering the submission of the APIO to be true.

The Commission hereby pass this order as given below;

- i) The Appellant to be present in the next date of hearing without fail, **failing which this instant appeal will be heard and determined ex-parte.**
- ii) The PIO to be present in the next date of hearing without fail, **failing which necessary action will be initiated as per the provisions of RTI Act 2005**
- iii) The next date of hearing has been intimated to the APIO as he is present during the hearing.
