SUMMON

WHEREAS, in connection with the **APIC-No. 1090/2023**, your personal appearance is required before the Commission on **18th June, 2026 at 10:30 AM**. The 4th hearing held on 31st March' 2026. The Appellant Shri Nabam Sono, present during the hearing and PIO-cum Director, Department of Environment and Project Coordinator Itanagar, is absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of the PIO and hereby orders;

- i) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing, as sought in his form 'A' application. **Failing which appropriate action shall be initiated against the PIO as per the provision of RTI Act, 2005.**
- ii) The Appellant to be present in person or through online mode before the Commission in the next date of hearing. Without fail. **Failing which this appeal shall be heard and determined ex-parte.**

Due to absence of PIO, the Commission could not proceed the hearing of the appeal.

The next date of hearing be fixed on 18th June 2026 at 10:30 AM
