WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 196/2025**, your personal appearance is required before the Commission on **04th June, 2026 at 10:30 AM**. The 3rd hearing held on **19th March' 2026**. The Appellant Shri Nabam Tapak is absent without any letter of absence submitted to the Commission, whereas, he was personally present in the 2nd hearing held on 13.11.2025 and notified of the next hearing, which is today.

The absence of the Appellant makes the Commission take serious note of the absence despite being the Appellant. Such absence let the Commission consider that the Appellant is not at all serious on his appeal.

The PIO-cum-EE, RWD, Poma Division, Papumpare District, Govt. of Arunachal Pradesh is absent despite of repeated notice for hearing served unto the PIO, the repeated absence of the PIO paying no heed to the Arunachal Pradesh Information Commission orders, the Commission hereby taking serious note of the repeated absence of the PIO pass the below orders;

- i) Send Summons to the Appellant to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.
- ii) Issue Bailable Warrant of Arrest against the PIO-cum-EE, RWD, Poma Division, Papumpare District, Govt. of Arunachal Pradesh to secure his attendance in the next date of hearing.
- iii) Send the Bailable Warrant Arrest to the Officer-In-Charge, Yupia Police Station to execute and return the warrant of arrest before the Arunachal Pradesh Information Commission (APIC) without fail and on time.
- iv) Send copy of Bailable Warrant of Arrest to the Superintendent of Police, Yupia to oversee the arrest of the PIO-cum-Executive Engineer, RWD, Poma Division, through the Officer-In-Charge, Yupia Police Station.

- v) Send a copy of the Bailable Warrant of Arrest to the Deputy Commissioner (DC), Yupia for information and necessary action.

The Commission hereby orders;

The next date of hearing be fixed on 4th day of June' 2026 at 10:30 AM (Morning).
