ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Takey for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD) Sangram Division, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 03.01.2025.

A) Particulars of information: C/o approach road construction from BRO Helipad Lee to CO-cum-BDO Residence via Hospital, General ground CO-cum-BDO office Sarli Town.

B) Details of information:

1. DPR of the said project in details;
2. Work order of the said project;
3. MIS report geo tagged report and geo tagged certificate;
4. Name of the firm in details;
5. NIT date of publication copy (local news paper cutting c/o said project);
6. Total fund allocation for the project said;
7. Technical sanction copy of the project and
8. Board member of the said project at the time of NIT in designation with sign details.

C) Period for which information asked for: 2023-2025.

Brief facts emerging from the appeal:

Records emerging from the appeal disclose that the Appellant, Shri Pisa Takey had requested the PIO for the aforementioned information / documents but failed to obtain the documents from the PIO/FAA which prompted him to appeal before the Chief Engineer (PWD), Govt. of A.P, Central Zone-A, Itanagar as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 24.03.2025.

Records further reveal that the appeal was returned to the FAA to adjudicate the appeal under section 19(1) of the RTI Act by giving both the parties fair and reasonable opportunity to be heard and pass appropriate direction within 30 days.

However, the appellant failed yet again to obtain the information and therefore, he filed his 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of appeal dt. 14.05.2025.

This appeal is, accordingly, listed today on 25.02.2026.

The appellant, Shri Pisa Takey is present in person while the PIO is represented by Shri Bini Tare, the PA-cum-RTI i/c o/o the EE (PWD) Sangram Division.

Hearing and decision:

Heard the appellant who, reiterating his demand for the information/documents from the o/o the PIO, pleaded for an appropriate direction to the PIO to furnish the requested information to him. The representative of the PIO submitted that with the bifurcation of the Koloriang PWD Division from the Sangram PWD Division, the documents related to the schemes coming under the jurisdiction of Koloriang Division, including the RTI matters, had been transferred to the Koloriang Division and therefore, the PIO o/o the EE, Koloriang PWD Division should be directed to furnish the requested information. The representative of the PIO, however, did not produce any Govt. order/notification regarding the transfer/handing over of the subjects under the jurisdiction of the Koloriang Division as claimed by him.

In the premises as above, this Commission deems it appropriate to hear the PIOs of both the Sangram Division and the Koloriang Division so as to enable this Commission to decide as to whose office shall furnish the requested information/documents to the appellant.

The PIO, o/o the E.E(PWD) Koloriang Division and the PIO o/o the E.E (PWD), Sangram Division are, therefore, directed to be present in person in the next hearing on 25.03.2026 with records / evidence of handing over and taking over of the charges of records/documents pertaining to schemes falling under the jurisdiction Koloriang Division.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 25th March, 2026 (Wednesday) at 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
