An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC- 714/2025.

(Summon to appear in person)

(Or.5 R.3 of CPC)

APPELLANTS : Shri Tanya Ronya and Shri Penter Ronya, Yeggo Hydel Road, Aalo.

RESPONDENT : The PIO, o/o the E.E (PWD), Yomcha Division, West Siang District.

ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tanya Ronya and Shri Penter Ronya for non-furnishing of below mentioned information by the PIO, o/o the E.E (PWD), Yomcha Division, West Siang District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 22.04.2025:

C) Particular of information:

- i) Furnish the details of expenditure and copy of Voucher of the following work.
- ii) Also furnish the information as per the format attached Annexure-A

D) **Details of information required:**

1. Upgradation of Yomcha ADC HQ to Liromoba EAC HQ road (CMCSRDP-II).
2. c/o Mini Secretariat ADC Yomcha.
3. c/o Mini Secretariat at Kamba.
4. c/o road from Boghne PMGSY road to Kambu village under Kamba Circle, West Siang District.
5. Multipurpose Community Centre at Kamba.

This appeal was listed for 5(five) times on 24.12.2026, 06.02.2026, 27.02.2026, 06.05.26 and 12.06.26 and the following orders were passed:

(a) 24.12.26:

"This Commission, upon hearing the appellant and on perusal of the points as contained in the Annexure-A to the RTI application on which the information / documents have been sought, noticed that the requested information / documents were not covered by any of the exemption clauses of section 8(1) of the RTI Act, 2005, had endorsed the direction of the FAA to furnish the same and hence, directed the PIO to furnish the requested information to the appellants within 1(one) months of the receipt of this order and report the compliance thereof to this Commission on the next date of hearing 06.02.2026. It was, however, made clear that if the o/o the PIO does not hold any of the requested information/documents, he shall declare so by way of an affidavit as required under section-18(3)(c) of the RTI Act, 2005 and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005."

b) 27.02.2026:

"This Commission noticed that despite order dt.24.12.25 the PIO failed to comply with the direction of the Commission nor did he attend the hearing on 06.02.26 which amounted to blatant disrespect to this Commission and the RTI regime attracting the penalties prescribed under the Act. The PIO, Er. Shri Doge Nyigyor,

the E.E (PWD), Yomcha Division was, therefore, issued notice dt.06.02.26, directing him to appear in person on **27.02.2026 (Friday) at 3.30 pm** and show cause as to why penalty prescribed under section 19(8)(c) r/w section 20 of the RTI Act, 2005 should not be imposed on him for non-compliance of the direction of this Commission and violation of the provisions of RTI Act, 2005.

Today on 27.02.26, the PIO, Er. Shri Doge Nyigyor, EE (PWD), Yomcha Division appeared in person but without explanation showing the reasons for his non-appearance in the hearings. He, however, brought in some of the requested information/documents but without forwarding letter showing the details of information being furnished. As such the documents have been returned to him to resubmit with proper forwarding letter showing the replies /information in tabular form and with proper paging and indexing.

The show cause notice dt.06.02.2026 is kept in abeyance. The PIO is, however, directed to resubmit to the appellant the information/replies with proper forwarding letter showing the replies /information in tabular form and with proper paging and indexing and report the compliance therewith to this Commission on **27.03.2026 failing which the said show cause notice shall be revived and the consequential penal action shall be taken against him without further opportunity of hearing.**"

c) 27.03.2026:

"On 27.03.2026, the appellant, Er. Shri Tanya Ronya was present through VC but the PIO was absent without any intimation despite categorical warning that if he fails to comply with the order of this Commission and intimate this Commission today on 27.03.2026, the show cause notice dt.06.02.26, since kept in abeyance, shall be revived and the consequential penal action shall be taken against him without further opportunity of hearing. The absence of the PIO today is, probably, due to his pre-occupation in the financial year ending works.

In the premises as above, the hearing of this case is adjourned to 06.05.2026 with the consent of the appellant. This Commission at the same time, reiterates its earlier direction to the PIO."

d) 06.05.2026:

"Both the parties are, however, absent without any intimation which makes this Commission presume that the PIO has furnished the information/documents as directed by this Commission in its aforesaid interim orders with which the appellant is satisfied. As such this Commission concludes that this appeal does not require any further adjudication in this Commission and accordingly, it is disposed of and closed."

This appeal was, thus closed vide order dt.06.05.2026. This Commission, however, received a letter dt.08.05.2026 from the appellant, Shri Tanya Ronya (as reproduced hereunder) stating that despite this Commission's repeated direction, the PIO failed to furnish the requested information and as such requested for summoning and issuing appropriate direction to the PIO to furnish the information.

Sir,

Please refer your above Memo No. where in my appeal seeking information from PIO EE Yomcha PWD has been closed on the presumption that PIO has furnished the information/documents to me (appellants) and due to non-attendance.

Sir, it is to bring to your kind notice that Commission has given ample opportunity to PIO EE PWD Yomcha i.e twice on dated 06.02.2026 and 27.03.2026 to furnish the information/documents with proper indexing and paging to appellants. Though he agreed during hearing but the PIO has not yet furnish the information which reflects his intentional refusal.

Thereafter Commission fix another date 06.05.2026 for hearing. Though your good office conveyed the cause list to me through WhatsApp, I could not appear the hearing and could not inform the commission in advance due to my inadvertent mistake.

The closure of the case by ex-parte on the ground of non-attendance for just one hearing amounts to not giving me opportunity and has defeated very purpose for which documents was sought through RTI

I would therefore request you to kindly issue notice to the PIO Shri Doge Nyigyor EE PWD Yomcha to furnish the documents as ordered by your good office dated 06.02.2026 and 27.03.2026

In view of the complaint from the appellant as above, this Commission, vide order dt. 26.05.2026, reviewed the order dt.06.05.2026 and listed the appeal again on 12.06.2026 with direction to the PIO to comply with this Commission's earlier orders (supra).

On 12.06.2026, the appellant appeared through VC who informed that he has received message from the o/o the PIO that the requested documents/information are ready and that he will collect the same within 1(one) week and report his satisfaction or otherwise thereon to this Commission. The appellant was, accordingly, directed to collect the documents and intimate this Commission of the receipt of the same within 1(one) week from the date of order.

In compliance with the order dt.12.06.26, the appellant, vide his letter dt.18.06.26 (as reproduced below), informed that he has received the requested information from the PIO but complained that 90% of the requested information has not been furnished and as such he pleaded for appropriate action against the PIO under the RTI Act.

“Sir.

With reference to above subject and reference I am to inform you that

- i) Information furnished is incomplete and has not followed the format which supplied. (as per Annex-A)*
- (ii) the information for five works was sought but only one work information furnished. (List of works Annex-B)*

In this connection I am to inform you that I have received the information from PIO Yomcha Executive Engineer on 16th June 2026 and found that the 90% of the information sought has not been furnished.

The information of only one work i.e. c/o Mini Secretariat at Kamba is received.

Under the above facts and circumstances I request you to kindly take appropriate action such that PIO furnishes the information sought by me at the earliest possible time.

In the premises as above, the PIO is directed to furnish the left out information to the appellant and report the compliance therewith on 24.07.2026 failing which the penal action under section 20 of the RTI Act shall be invoked against him.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
