SUMMON

WHEREAS, in connection with the **APIC-No. 325/2025**, your personal appearance is required before the Commission on **2 June, 2026 at 02:30 PM**. The 1st hearing held on **17 March' 2026**. The Appellant Shri Pegmir Punu is present during the hearing before the Commission.

The PIO-cum-EE, PHE & WS, Raga Division, Kamle District, Govt. of Arunachal Pradesh found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant;

The Appellant stated that the PIO has furnished all the information(s) to him except the name of the Firm to whom the work has been awarded and payment made.

After hearing the Appellant and going through the copies of the information(s) provided by the PIO to the Appellant, the Commission also find that out of seven (7) listed Firms to whom the work was awarded and payment was made, is not provided to the Appellant.

Under the above observations, the Commission hereby pass the below orders;

- i) The PIO-cum-EE, PHE & WS, Raga Division, Kamle District, Govt. of Arunachal Pradesh to provide the name of the Firm to whom the work was awarded and payment made on or before the next date of hearing to the Appellant and to be present in the next date of hearing without fail, failing which necessary action as provided under the RTI, Act, 2005 will be initiated against the PIO.

- ii) Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this appeal will be heard and determined ex-parte.
- iii) Notice for next date of hearing be sent to the PIO.
- iv) Notice need not be sent to the Appellant as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 2nd day of June' 2026 at 2:30 PM (Evening).


