ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Ms. Bengia Mama for non-furnishing of 27(twenty seven) point information on Upgradation of Health Infrastructure at PHC Yangte under Kra Daadi District by the PIO, o/o the EE (RWD) Janmin Division, Kra Daadi District as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 05.01.2026.

● The appeal was, accordingly, listed and heard on 24.07.2026 wherein the appellant was present in person but the PIO did not appear.

This Commission, after hearing the appellant that the PIO did not furnish complete information and also noticing that the requested information / documents are not covered by the exemption provisions of section 9 or 8 of the RTI Act, 2005, had directed the PIO by order dt.24.07.26, to furnish the same to the appellant so as not to constrain this Commission to invoke the penal provisions of RTI Act. *It was also made clear that as required by section -7(8)(i) read with section-18(3)(c) of the RTI Act, 2005 and under rule- 5(vi) of the A.P Information Commission (Appeal Procedure) Rules, 2005, an appropriate reply/explanation shall be furnished in respect of the queries against which the replies/information are being denied to the applicant at right earnest and report the compliance thereof to this Commission on 09.09.2026 the next hearing date.*

Today on 09.09.2026, the PIO is again absent without any information while the appellant is present in person and complained that the PIO failed to comply with the this Commission's order dt.24.07.26 and demanded penal action against him.

Taking a serious view of the absence of the PIO, this appeal is listed again on 9th October, 2026 and in the interim the PIO is again directed to furnish the left out information as already directed in the last order dt. 24th July, 2026 and report compliance thereof on 9th Oct. 2026, the next date of hearing so as not constrain this Commission to invoke the penal provision of the RTI Act 2005.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC in person on 9th October 2026(Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

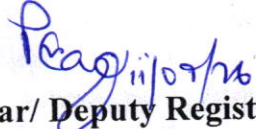
Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined, including closure of the appeal, in your absence.
