**SUMMON**

**WHEREAS**, in connection with the **APIC-No. 742/2025**, your personal appearances required before the Commission on 11<sup>th</sup> **June 2026 at 10:30 AM**. The 1<sup>st</sup> hearing held on 26<sup>th</sup> March '2026. The Appellant Shri Dongru Tania, present during the hearing. The PIO –cum EE (WRD) Ziro Division District Lower Subansiri Govt of AP is absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

**Heard the Appellant;**

The Appellant stated before the Commission that the information as applied have not been furnished by the PIO, so he has filed this second appeal before the Arunachal Pradesh Information Commission(APIC).

**In the absence of the PIO, the Commission could not proceed the hearing of the appeal and so orders;**

- i) To **issue summons** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per provisions of RTI Act 2005.**
- ii) The Appellant to be present in person or through online mode before the Commission in the next date of hearing. Without fail. **Failing which this appeal shall be heard and determined ex-parte.**
