SUMMON

WHEREAS, in connection with the **APIC-No.774/2025**, your personal appearances required before the Commission on **9th June 2026 at 02:30 PM**. The 1st hearing held on **24th March' 2026**. The Appellant Shri Bengia Tahar is present during the hearing before the Commission.

The PIO-cum-DLRSO, Koloriang, Kurung Kumey District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

- i) The **Summons** be issued to the PIO to be present in the next date of hearing in person or through online mode without fail, failing which appropriate action will be initiated against the PIO as per the provisions of the RTI, Act, 2005.

- ii) The Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this appeal will be heard and determined ex-parte.
- iii) Notice for next date of hearing need not be issued to the Appellant as he is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 9th day of June' 2026 at 2:30 PM (Evening).
