Information sought:

The appellant filed an RTI application dated 04.09.2025 seeking following information regarding

C/o "Total nos. of Projects sanctioned and executed under Director TRIHMS for each financial year from the financial year 2017-18 to till date.

There particulars of information required are as follows:-

1. Furnish the certified copy of total amount of Fund allocated (in whatever form may be) for each project in respect of all the Projects/ works undertaken under Director of TRIHMS for each Financial year from 2017-18 to till date.
2. Furnish the certified copy of Total amount of Labour Cess of 1% of mandatorily deducted under the Building and Other Construction Workers' Welfare Cess Act, 1996 (Cess Act) from all the fund allocated against each project in respect of all the projects/works executed under Director, TRIHMS for each financial year from 2017-18 to 2025-26.
3. Furnish the certified copy of total amount deducted in respect of, Contingency charges, from each project in respect of all the works/projects executed under the Director TRIHMS for each financial year from 2017-18 to 2025-26.
4. Furnish the certified copy of expenditure details (along with supporting documents) of Contingency charges deducted from each project in respect all the work/projects executed under the Director of TRIHMS for each financial year from 2017-18 to 2025-26.
5. Furnish the certified details of Officers (Name & Designation then & now) who are responsible for deducting Labour cess and Contingency charges from the all projects/work executed under the Director of TRIHMS for each financial year from 2017-18 to 2025-26.
6. Furnish the certified details of Officers (Name & Designation then & now) who are responsible for depositing the Labour cess for the all projects/work executed under the director of TRIHMS to the competent authority (i.e. APB&) CWWB) for each financial year from 2017-18 to 2025-26.
7. Furnish the certified copy of Labour Cess deposited to the competent authority (APB&OCWWB or Labour commissioner) by the Executing Agency along with the supporting documents (such as Challan, Cheque counterfoil, Demand draft etc. whichever method is used) for each financial year from 2017-18 to 2025-26.
8. Furnish the certified details of third-party officer/Audit Officer for verifying whether the proper/right amount of Labour Cess was deposited to the concern authority for each financial year 2017-18 to 2025-26.

The following were present.

- Appellant** : Present. He states that neither the FAA has heard the appeal nor the PIO has furnished information.
- Respondent PIO** : Present. He states that the information could not be furnished within the stipulated time period as per RTI Act as the finance and account branch of TRIHMS did not give information document. He sought 3 weeks-time to gather the information and to furnish it to the appellant.
- FAA** : **Absent.**

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, hearing the parties, observes that the then FAA has not heard the PIO and Appellant in this appeal case. The PIO has not furnished the information to the appellant. The PIO is directed to furnish the information to the appellant within 3 weeks from the date of issue of this order i.e on or before 13 April 2026 under intimation to this commission. The appellant is directed to submit a status report upon receipt of the information document to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within the stipulated time, this appeal case shall stand closed.
