**ORDER**

The 1<sup>st</sup> hearing held on 26<sup>th</sup> March '2026 related to the **APIC No-794/A/2025**. The Appellants represented by Shri Birenora Tallong, present during the hearing and the PIO – cum EE (WRD) Itanagar Division, represented by Shri Tapu Likha, Chief Additional Estimator (WRD) with an authorization letter from the PIO.

**Heard the Appellant;**

The Appellant stated before the Commission that he has filed his form 'A' on **21/7/2025** and not getting information from the PIO. He filed the First Appeal before the First Appellate Authority –cum- CE W/Z (WRD) Itanagar Govt. of AP. Even after that information not been received from the PIO he has filed Second Appeal before the Arunachal Pradesh Information Commission (APIC).

**Heard the APIO;**

The APIO stated that upon receiving the form 'A' on **23/07/2025** I have written a letter to the Appellants on **20/08/2025**, to pay an amount of **Rs 7646( Rupees seven thousand six hundred forty six)** only for the cost of information running to **3823** pages and posted the letter through registered post on **21/08/2025**. Even after that, the Appellants have not paid the fees and therefore the information have not been provided to the Appellants till today.

**After hearing both the parties and going through the documents as produced by both the parties the Commission hereby observes;**

The form 'A' of the Appellants submitted to the PIO on **21/7/2025**. The PIO replied to the Appellants to submit necessary fees for the information on **20/8/2025**, through a registered letter posted on 21/8/2025, but despite of the letter written to the Appellant by the PIO. The Appellants have not deposited the fees till today.

**Under the above observations the Commission hereby pass the below orders;**

- i) The Appellants to pay an amount of **Rs 7646 ( Rupees seven thousand four hundred forty six)** only through e-payment Treasury Challan in favour of PIO – cum EE (WRD) Itanagar Division on or before the next date of hearing to get the information.

- ii) Appellants to pursue the PIO after payments of the fees and collect the information and let APIC, know whether they have been provided with complete information or not.
- iii) The Appellant to appear in person or through online mode before the Commission, in the next date of hearing without fail, **failing which his appeal shall be heard and determined ex-parte.**
- iv) The PIO to furnish the complete information as applied by the Appellants on remittance of fees for the information on or before the next date of hearing and to attend the next date of hearing without fail, **failing which appropriate action shall be imitated against the PIO as per the provisions of the RTI Act 2005.**
- v) The next date of hearing has been intimated to both the parties.
- vi) Notice need not be issued to the parties as they are present during the hearing.

**The Commission hereby orders;**

**The next date of hearing be fixed on 11<sup>th</sup> June 2026 at 10 :30 AM (Morning).**
