An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC- 446/2026.

APPELLANT : Shri Tamchi Gungte near KV-II Chimpu.
RESPONDENT : The PIO, o/o the EE (PHE & WS), Likabali Division,

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the EE (PHE & WS), Likabali Division, Lower Siang District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 24.01.2026.

A. Particular of information: C/o "total list of completed Plan & Non-plan Works/projects sponsored by State fund/Central fund or both (such as SIDF/ BE/ RE/ RIDF/ SADA/ ADA/ MLA-LAD/ MP-LAD/ SPA /Article275(1)/ PMJVK/ PM-DevINE/ NEC/NESIDS/ Non-BADP/ SASCI, JJM/ NRDWM/SPM/ Maintenance of water supply works in the division etc.) executed under the concern division" from the financial year 2016-17 to 2025-26.

B. Details of information required:

1. Copy of Total list of works/projects (Plan & Non-Plan) by the division under various scheme head mentioned above (state/central scheme or both as mentioned above), for each financial year from 2016-17 to 2025-26.
2. Copy of sanction order/ Administrative approval (AA) & Expenditure sanction (ES)/ Administrative and financial sanction (AFS) of each completed projects in respect of Sl. No. 1 mentioned above for each financial.
3. Copy of Technical Sanction (TS) Order Copy of each completed projects in respect of serial no. 1 mentioned above for each financial year from 2016-17 to 2025-26.
4. Copy of Agreement (in affidavit form) made between the Contractor and Executing Agency, for each completed projects/works in respect of serial no.1 mentioned above from the financial 2016-17 to 2025-26.
5. Furnish the certified copy of Work Order (with amount mentioned) lasued to the contractor with respect to serial no. 1 above. (only for the works/projects awarded in work order system) 2016-17 to 2025-26
6. Furnish the certified copy of UC (Utilization Certificate) of each completed projects in respect of serial no. I mentioned above for each financial year from 2016-17 to 2025-26.
7. Furnish the Details of fund Surrendered to the Govt. Head Account, in respect of serial no. 1 of my form-A:
 - c) Remaining balance amount after A/A E/S and TS has been done. (Enclosed the proof of surrender such as Challan copy or whichever method has been used.)
 - d) Remaining Balance amount after TS and Contract Agreement of the project/work. (Enclosed the proof of surrender such as Challan copy or whichever method has been used)
8. Furnish the Details of Expenditures of fund if been utislised, in respect of serial no. 1 of my Form-A:-

- a) Remaining balance amount after A/A E/S and TS has been completed. (Enclosed the proof of Expenditure.)
- b) Remaining Balance amount after TS and Contract Agreement/work order amount of the projects/works. (Enclosed the proof of expenditure)
9. Furnish the certified details of Officers (name & Designation then & now) who authorized/approve the surrender process of fund in respect of serial no. 7 of the Form-A.
10. Furnish the certified details of Officer who authorized/approve the expenditures of fund in respect of serial no. 8 of Form-A.
11. Furnish the Rules followed by the concern Officers (under CPWD works manual/ any other etc.) that authorize the officers to make an expenditures of fund beyond the Contract agreement/Work Order amount in respect of the projects/works.
12. Furnish all the above documents with CTC & proper manner (i.e. in serial wise with properly Index, proper paging of each financial year and separate books for each financial year for easy & better understanding).

Brief records emerging from the appeal:

Records in the appeal reveal that the appellant had requested for the aforementioned information from the PIO but failed to obtain the same which prompted him to file his 1st appeal under section 19(1) of the RTI Act before the CE, Central Zone, PHE & WS Deptt. Bene, Aalo West Siang District Govt. of A.P. the First Appellate Authority (FAA) vide his memo of appeal dt.23.03.2026.

Records further disclose that the FAA conducted the hearing on 27.05.2026 and passed the following order:

"ORDER

The above mentioned first appeal filed by the appellant under section 19(1) of the Right to Information Act, 2005 was fixed for hearing on 12th May 2026 and subsequently rescheduled on 26th May 2026.

Notice for hearing was duly served to the appellant and the concerned PIO. However, despite repeated opportunities being provided, the appellant failed to appear during the hearings without furnishing any reasonable cause or prayer for adjournment.

The respondent PIO (Executive Engineer PHE & WS Division Likabali), through his authorized representative, appeared and submitted the relevant records/documents for examination. The records available in the case file have been carefully examined. The appellant may collect the documents from the office of the PIO cum Executive Engineer PHE & WS Division Likabali. At the same time, the PIO cum Executive Engineer PHE & WS Division Likabali is directed to hand over the RTI documents to the appellant, in proper receipt and submit a copy of it, to the office of the First Appellant Authority, PHE & WS Department, Central Zone Bene for record.

Since the sufficient opportunity has already been afforded to the appellant and no response has been received from his side, the undersigned is left with no alternative but to decide the matter ex-parte on the basis of records available.

No further intervention appears necessary in the matter. Accordingly the appeal is hereby disposed of ex-parte.

If aggrieved by this order, the appellant may prefer a second appeal before the concerned State Information Commission as applicable within the prescribed period under the RTI Act.2005.
