Shri T. Yomdo -V/S- PIO-Cum-EE, PWD, Seppa, E/Kameng District A.P.

ORDER

The 1st hearing held on **17th September' 2026'** related to the **APIC No-451/A/2026**.
The Appellant Shri T . Yomdo is present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), PWD, Seppa Division, East Kameng District, Govt. of Arunachal Pradesh is represented by his APIO Shri Hinda Remo, ASW through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the PIO has not provided him any information till now, even though his Form-A was delivered through Registered Post on 25.11.2025 as per the records of the India Post.

Heard the APIO;

The APIO stated that the office of the PIO has not received any application/Form-A from Mr. T . Yomdo till now and that is the reason the office of the PIO has not gone through the Form-A, and therefore, has not provided any information to the Appellant till now.

The APIO requested the Commission to provide a copy of the Form-A of the Appellant to the office of the PIO, so that the PIO can go through the Form-A and provide the information which are available with the office of the PIO, and so the APIO has provided a working Mobile Telephone Number by which the Appellant is requested to send the Form-A through Whatsapp messaging app and the number provided is of the staff who deals with all RTI matter and the Number is 7629964987.

After hearing both the parties the Commission hereby orders;

- i) The Appellant to send the Form-A through the above provided Mobile Telephone Number of the staff on Whatsapp messaging app as soft copy today itself and contact the office of the PIO after a week from today about the information being readied or not.
- ii) The Appellant to be present in the next hearing without fail, failing which the Commission will presume that the Appellant has received the complete information from the PIO, and thereby, the Commission will decide this appeal ex-parte and dispose this appeal.

- iii) The PIO to be present in the next hearing without fail, failing which the Commission will initiate necessary action against the PIO as per the provisions of RTI, Act, 2005.
- iv) Notice for the next hearing need not be sent to both the parties as both the parties are present today and in know of the next date of hearing.

The Commission hereby orders;

The next date of hearing be fixed on 26th day of November' 2026 at 10:30 AM (Morning).
