ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed Shri Riya Taram, Huto Colony Jullang, C/o Riag Store Jullang near Catholic Church Jullang, Itanagar, Arunachal Pradesh, PIN-791113 for non-furnishing of information by the PIO-Cum- EE PWD), Hayuliang Division, Anjaw District, Arunachal Pradesh, Pin: 792104 as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 31/03/2026 regarding **LOC issued amounting to Rs. 812.73 for the month o January 2026.**

2). **The 1st hearing was held today on 15th September 2026 (Tuesday) at 1100 hrs. The PIO-Cum- EE PWD), Hayuliang Division, Anjaw District, Arunachal Pradesh attended the hearing on line.**

3). The PIO informed the Commission that he had received the RTI application Form 'A' on 10th April' 2026. He wrote a letter and dispatched it through postal services to the Appellant Vide No. HD/AC-19/RTI-2025-26/220-23 Dated 4th May' 2026 asking him to collect the information **by deposit as e-challan Rs. 2,446.00 (Rupees two thousand four hundred forty six) only.** But till date no reply has been received from the Appellant and therefore, it is presumed that the Appellant was not interested to collect the information.

4). The Appellant, Shri Riya Taram was found absent though he had submitted an application today on 15/09/2026, addressed to the Commission, requesting for adjournment of the case on health ground stating that he was suffering from fever and cough for the last 3 (three) days.

5). The Commission found the reason for absence un- acceptable, and opined that the appellant could have attended the court today through online mode of hearing from any place/location.

Therefore, the case is disposed of. However, if the Appellant submits medical report as a proof by providing details from where he had undergone medical treatment as an in-door or out-door patient with proper registration Number, then the case could be reviewed for the next course of action. **The Medical certificate be provided by 25th September 2026, failing which the case will be closed.**
