O R D E R

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpoo, PO/ PS Chimpoo, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding MRL20-Namtok EAC HQ to Nakang during the financial year 2024-25.

2). **The 2nd hearing was held today on 22nd July' 2025 (Tuesday) at 1100 hrs. Er. Nyamar Rike, the PIO-Cum- EE (RWD), Govt. of A.P., Changlang Division, Changlang District, Arunachal Pradesh was present in the court hearing through hybrid mode.**

3). Shri Tamchi Gungte, the Appellant was present in person before the Commission. The Appellant informed that he had received a copy of information but while verifying the documents in detail, it was found to be unsatisfactory. Hence, he appealed the Commission to direct the PIO to furnish authentic and correct documents. He further contended that sanction order copy was also not provided; instead sanction proposal approved order copy of the Central Government was provided.

4). Er. Nyamar Rike, the PIO-Cum- EE (RWD), Changlang Division stated that he had furnished all documents through speed post by postal services and that all information sought by the Appellant in Form-“A” had been furnished completely. However, alleged that the Appellant was not keen to get information rather he was trying to harass the officer. The PIO stated that the Appellant was summoned to appear before the FAA-Cum- SE (RWD), Namsai on 05/02/2025 but failed to attend the court hearing.

5) Due to contradiction of views of both the parties i.e. PIO and the Appellant, the Commission directed Shri Tamchi Gungte, the Appellant to make a correct list of non-furnished documents to the PIO with a copy to the Commission within 15 days from the date of issue of this letter. At the same time the PIO is directed to provide a copy of the sanction letter issued by the concerned department of the Govt. of Arunachal Pradesh contrary to the stand

taken by the PIO on the subject. On receipt of the non-furnished information from the PIO, the Appellant is directed to intimate the Commission his satisfaction or dis-satisfaction. Based on the information feedback of the Appellant, the Commission shall decide the next course of action.

No next date of hearing shall be fixed till the receipt of non furnished list of documents from the Appellant.

Order copies be issued to all the parties.
